PREFATORY STATEMENT

WHEREAS, on October 21, 2011 the Sangguniang Panlungsod ng Ormoc enacted Ordinance No. 168, otherwise known as the "REVISED AND UPDATED CIVIL REGISTRY FEES AND CHARGES OF 2011" of the City of Ormoc;

WHEREAS, there is a need to temporarily suspend the implementation of certain provisions thereof, particularly those pertaining to registry fees as provided in Section 3A, Nos. 1-3 of said Ordinance No. 168. This suspension of implementation is to conform with the provisions of the Memorandum of Agreement (MOA) being entered into by the Honorable City Mayor for and in behalf of the City of Ormoc for the implementation of the Mobile Registration Project of the United Nations High Commissioner for Refugees (UNHCR) in collaboration with the City Civil Registry and other concerned agencies;

WHEREAS, the MOA involves the processing and retrieval of civil registration or proof of birth, death and marriage that may have been damaged or lost due to Typhoon Yolanda. The duration of the project is from April 7 to June 30, 2014 and is construed to benefit many Ormoc City residents for whom the issuances of birth, death and marriage certificates will be rendered free of charge;

WHEREAS , the 13th Sangguniang Panlungsod ng Ormoc finds the MOA advantageous and beneficial to the people thus, it has given express authority to the Honorable City Mayor Edward C. Codilla to sign the same as embodied in SP Resolution No. 2014-066 dated April 15, 2014;

WHEREAS, in order to properly implement the provisions of the MOA covering the Mobile Registration Project in Ormoc City as approved by this Sanggunian per SP Res. No. 2014-066, the matter calls for the passage of appropriate measure waiving the fees prescribed in Section 3A, Nos. 1-3 of Ordinance No. 168, but only for the period from April 7 to June 30, 2014;

WHEREAS, Section 192 of Local Government Code of 1991 states that:

SECTION 192. Authority to Grant Tax Exemption Privileges.

Local Government Units may, through Ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Pedro Godiardo P. Ebcas, Member, Committee on Ways and Means, severally seconded by Honorable SP Members Benjamin S. Pongos, Jr., Mariano Y. Corro and Vincent L. Rama; be it

RESOLVED , to enact :

ORDINANCE NO. 006

AN ORDINANCE WAIVING THE CIVIL REGISTRY FEES ON THE ISSUANCES OF BIRTH, DEATH AND MARRIAGE CERTIFICATES IN ORMOC CITY, AND FOR THIS PURPOSE SUSPENDING THE IMPLEMENTATION OF SECTION 3A, NOS. 1 TO 3 OF ORDINANCE NO. 168 DATED OCTOBER 21, 2011 FROM APRIL 7 TO JUNE 30, 2014 ONLY.

BE IT ENACTED by the $13^{\rm th}$ Sangguniang Panlungsod ng Ormoc , in regular session assembled, That:

SECTION 1. The Registry Fees provided in Section 3A, Nos. 1 to 3 of Ordinance No. 168 is hereby WAIVED during the period April 7 to June 30, 2014 in connection with the implementation of the Mobile Registration Project in the City of Ormoc wherein the issuances of BIRTH, DEATH and MARRIAGE Certificates shall be free of charge.

SECTION 2. The imposition of civil registry fees on the issuances of BIRTH, DEATH and MARRIAGE Certificates shall be immediately implemented and fully enforced in accordance with the provisions of Sec. 3A, Nos. 1 to 3 of Ordinance No. 168 on July 1, 2014.

SECTION 3. All other provisions of Ordinance No. 168 shall remain in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
