PREFATORY STATEMENT

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of a $1^{\rm st}$ Endorsement, dated July 30, 2015 concerning Barangay Resolution No. 8 series of 2015 from Barangay District XI requesting for the enactment of an ordinance designating Lypez Jaena Street as a one-side parking area;

WHEREAS, this august Body also received a request through Barangay Resolution No. 22 series of 2015 from Barangay District XII requesting for the enactment of an ordinance designating Padre Ismael Cataag Street as a one-side parking area;

WHEREAS, the Barangay, after its long-time observation on the traffic situation in said street, deems it necessary to designate the same as a one-side parking area to promote efficient flow of traffic and correspondingly prevent untoward incidents from happening and ensure the safety of the school children, the barangay constituents and the general public;

WHEREAS, Section 458 (a) (5) (v) and (vi) of Republic Act 7160, otherwise known as "The Local Government Code of 1991" provides for the powers and, duties and functions of the Sangguniang Panlungsod:

- (v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement repair and maintenance of the same xxx;
- (vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon xxx.

WHEREAS, , this august Body, after a thorough deliberation and scrutiny, shares the same view with both Barangays as to the need of designating the streets subject of request as one-side parking areas to promote orderly and efficient traffic flow and to ease the worsening traffic congestion problem on said streets;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Police, Fire and Penology, severally seconded by Honorable SP Members Mario M. Rodriguez, Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 018

AN ORDINANCE ADDING CHAPTER XV OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-103-A, ENTITLED: "AN ORDINANCE ORDANNING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DESIGNATING THE FOLLOWING STREETS AS ONE-SIDE PARKING AREAS: (1) PADRE ISMAEL CATAAG STREET FROM THE CORNER OF SAN PEDRO STREET TO THE CORNER OF ARRADAZA STREET; AND (2) LOPEZ JAENA STREET FROM THE CORNER OF ARRADAZA STREET TO THE CORNER OF SAN PEDRO STREET, THIS CITY, DURING SCHOOL DAYS (MONDAY TO FRIDAY).

BE IT ORDAINED by the 13th Sangguniang Panlungsod ng Ormoc, That:

SECTION I. Padre Ismael Catag Street from the corner of San Pedro Street to the corner of Arradaza Street, Barangay District XII, this City, is hereby designated as one-side parking area, in such a manner that vehicles are only allowed to park at the school-side (St. Peter's College).

SECTION 2. Lopez Jaena Street from the corner of Arradaza Street to the corner of San Redro Street, commonly shared by Barangay District XI and Barangay District XII, this City, is hereby designated as one-side parking area, in such a manner that vehicles are only allowed to park at the school-side (St. Peter's College).

SECTION 3. Any violation of the provisions of this Ordinance shall be punished by a fine of Two Hundred Pesos (Php 200.00) or an imprisonment of 5 to 10 days or both at the discretion of the court.

SECTION 4. Any ordinance or provision thereof in conflict with this Ordinance is hereby repealed.

SECTION 5. This Ordinance shall take effect immediately upon its approval and compliance of the posting and publication requirements.

ENACTED, October 01, 2015.

RESOLVED FURTHER, to direct the Chief of Police of Ormoc City to coordinate with the City Engineer and other concerned government officials and employees in putting up the necessary traffic signs in strategic areas in pursuance to the intents of this Ordinance.
