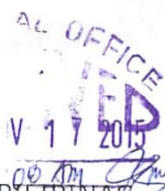
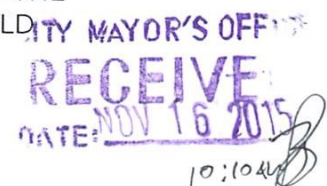

PREFATORY STATEMENT

WHEREAS, the 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc passed Ordinance No.19 otherwise known as "AN ORDINANCE ESTABLISHING THE RIGHTS AND OBLIGATIONS OF CHILDREN AND PERSONS WITH DISABILITIES RIDING TRICYCLE-FOR-HIRE IN ORMOC CITY" duly enacted on October 15, 2015;

WHEREAS, said ordinance, although passed, contains a clerical error in the third "WHEREAS" clause thereof;

WHEREAS, such "WHEREAS" clause as embodied in the ordinance states "**December 11, 2015**" as the date of issuance of the order from the Land Transportation Franchising and Regulatory Board (LTFRB) Case No. 2014-16849;

WHEREAS, in truth and in fact, the Land Transportation Franchising and Regulatory Board (LTFRB) Case No. 2014-16849 was actually issued on "December 11, 2014" in accordance with the copy of said order as duly received by this office;

WHEREAS, there is apparent discrepancy of facts in the Ordinance as duly passed by this august body which may cause confusion and may mislead the general public;

WHEREAS, this august body finds it necessary to correct the aforementioned discrepancy by way of amendment to correct such product of oversight;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the Honorable SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Transportation & Communication, severally seconded by the Honorable SP Members Antonio M. Codilla, Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, to enact:

ORDINANCE NO. 020

*AN ORDINANCE AMENDING THE THIRD "WHEREAS" CLAUSE IN THE PREFATORY STATEMENT OF ORDINANCE NO. 19 OTHERWISE KNOWN AS "AN ORDINANCE ESTABLISHING THE RIGHTS AND OBLIGATIONS OF CHILDREN AND PERSONS WITH DISABILITIES RIDING TRICYCLE-FOR-HIRE IN ORMOC CITY".*

BE IT ORDAINED, by the Thirteenth Sangguniang Panlungsod ng Ormoc in regular session assembled, that:

SECTION 1. This ordinance shall serve as an amendatory ordinance amending the third "WHEREAS" clause in Ordinance No. 19 otherwise known as "AN ORDINANCE ESTABLISHING THE RIGHTS AND OBLIGATIONS OF CHILDREN AND PERSONS WITH DISABILITIES RIDING TRICYCLE-FOR-HIRE IN ORMOC CITY".

SECTION 2. The third " WHEREAS" Clause in the Prefatory Statement of Ordinance No. 19 which originally read as:

"WHEREAS, in its Order, dated **December 11, 2015**, The Land Transportation Franchising and Regulatory Board (LTFRB) in Case No. 2014-16849, ordered all the drivers and operators the following directives:

1. Children less than one (1) meter in height shall be transported free of charge and those from above one (1) meter in height shall pay half fare. PUJ operators shall provide an adequate place in their motor vehicles the necessary markings for verifying the heights of the children passengers who are entitled to free or half fare pursuant to par. 11 of Memorandum Circular no.2011-004 entitled " 2011 Revised Terms and Conditions of CPC and Providing Penalties for Violation thereof."

Is hereby amended to read as follows:

"WHEREAS, in its Order, dated **December 11, 2014**, the Land Transportation Franchising and Regulatory Board (LTFRB) in Case No. 2014-16849, ordered all the drivers and operators the following directives:

1. Children less than one (1) meter in height shall be transported free of charge and those from above one (1) meter in height shall pay half fare. PUJ operators shall provide an adequate place in their motor vehicles the necessary markings for verifying the heights of the children passengers who are entitled to free or half fare pursuant to par.11 of Memorandum Circular no. 2011-004 entitled "2011 Revised Terms and Conditions of CPC and Providing Penalties for Violation thereof."

SECTION 3. This Ordinance shall take effect immediately after it shall have been published once in a local newspaper of general circulation within the City of Ormoc and posted in public places for at least three (3) consecutive weeks.

ENACTED, November 12, 2015.
