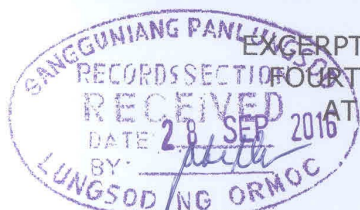
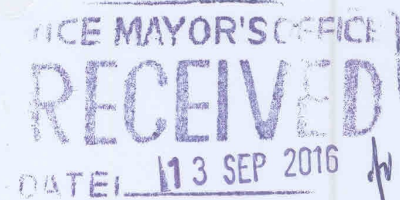
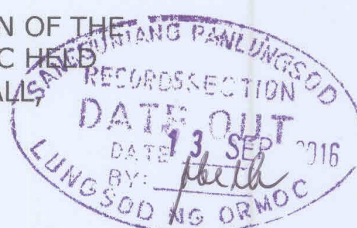

PREFATORY STATEMENT

WHEREAS, pursuant to Ordinance No. 172 series of 2012, the City Government of Ormoc held the Tugob Festival each year and during the charter day commemoration on October 20;

WHEREAS, the City Government of Ormoc spent more than PHP 1 Million Pesos each year just for the holding of the Tugob Festival;

WHEREAS, the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting for the repeal of Ordinance No. 174 series of 2012 pointing out as reasons and justifications the transition period of the newly elected and appointed city officials, upcoming barangay and SK elections, and requests from various agencies to coincide the holding of the Tugob Festival with the Ormoc City Fiesta every June of each year;

WHEREAS, initial information and feedback received indicates that moving the Tugob Festival to June each year is better to make the visits of many balikbayans more enjoyable, memorable and fun;

WHEREAS, the Charter Day Celebration of Ormoc City is also the commemoration of the Leyte Landing and most likely full media attention is in Palo for the said commemoration thereby limiting the potentials of the charter day celebration of Ormoc City as a tourism event and as attraction;

WHEREAS, the request for repeal may also be grounded on the call for assessment and evaluation on the concept of Tugob Festival before making a decision on how the festival can be made as a niche of Ormoc City and considering that Ordinance No. 174 contains very specific provisions, the Sanggunian is left with the only option to repeal the ordinance to give way to a study and come up with a recommendation as to the course of legislative action;

ORDINANCE NO. 008

**AN ORDINANCE REPEALING ORDINANCE NO. 174
SERIES OF 2012 ENTITLED "AN ORDINANCE
INSTITUTIONALIZING THE TUGOB FESTIVAL AND
FIXING THE DATE AND FUNDING THEREOF".**

SECTION 1. Ordinance No. 174, series of 2012, entitled "An Ordinance Institutionalizing the Tugob Festival and Fixing the Date and Funding Thereof" is hereby repealed.

SECTION 2. The Ormoc City Culture and Arts Council in coordination with the Ormoc City Tourism Council shall conduct a review and study on the Tugob Festival and come up with a recommendation on the nature and proper scheduling of the said festival.


SECTION 3. This Ordinance shall take effect immediately upon its approval.


