PREFATORY STATEMENT

The 14th Sangguniang Panlungsod ng Ormoc (this Sanggunian) was in receipt of an Indorsement Letter from the Office of the City Mayor dated May 16, 2017, which was certified as urgent by the City Mayor, requesting the Local Government Unit of Ormoc (LGU-Ormoc) for the closure and use of certain main roads in the City. Said temporary closure was requested by the Ormoc Fiesta Committee 2017 to be used as venue for its various activities in the promotion of the City's local businesses and products along with its pursuit of the City's tourism objectives.

In view thereof, and for aforementioned purposes, the temporary closure of portions of Burgos Street and Molave Street was urgently sought from June 01 to July 15, 2017.

Republic Act No. 7160, otherwise known as the Local Government Code of 1991, specifically Section 21 thereof, empowers the City, through this Sanggunian, to temporarily close or open any road, alley, park or square within its territorial jurisdiction through an ordinance, which paragraphs (a) and (c) specifically provides, to wit:

SECTION 21. Closure and Opening of Roads.

(a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, x x x falling within its jurisdiction: x x x x x,

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, x x x x, the duration of which shall be specified by the local chief executive concerned in a written order: x x x
x x x x x x

Further, this Sanggunian finds that the request is not contrary to law, contracts, public policy and customs and therefore, as reiterated, most deserving of its meritorious action.

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 033

AN ORDINANCE ALLOWING THE TEMPORARY CLOSURE OF CERTAIN STREETS IN THE CITY FOR THE CONDUCT OF VARIOUS ACTIVITIES TO PROMOTE LOCAL BUSINESSES AND PRODUCTS AND BOOST TOURISM ON THE OCCASION OF THE CITY'S FIESTA 2017.

BE IT ORDAINED by the Fourteenth Sangguniang Panlungsod ng Ormoc, in REGULAR SESSION assembled, that:

SECTION I. COVERAGE. This Ordinance shall cover the temporary closure of certain streets from June 01, 2017 to July 15, 2017. The roads object of the foregoing are the following:

- a. The whole of Molave Street;
- b. A portion of Burgos Street cornered by J. Navarro Street and Malacadios Street.

For better guidance in the implementation of this Ordinance, attached hereto and made an integral part herein is the vicinity map showing the portions of the roads subject to herein closure.

Said temporary closure shall be strictly imposed on the areas and date specified. In this pursuit, all public and private vehicles shall be prohibited to enter or pass the affected premises.

SECTION II. RATIFICATION. In the event that the approval and effectivity of this Ordinance comes belatedly after the subject event, this august Body hereby ratifies the closure to be effected for said event on the subject date.

SECTION III. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval subject to the compliance of the necessary posting and publication requirements as provided for in the Local Government Code of 1991.


