# PREFATORY STATEMENT

WHEREAS, Article XIV, Section 19 (1) of the 1987 Constitution provides that "The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry";

WHEREAS, Republic Act No. 9064 enacted on April 5, 2001, otherwise known as "AN ACT GRANTING CASH AND OTHER NON-MONETARY BENEFITS AND INCENTIVES TO NATIONAL ATHLETES, COACHES AND TRAINERS, and APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES";

WHEREAS, the City of Ormoc in conformity with RA 9064 shall promote excellence in sports and through sports by providing for the welfare of national athletes, coaches and trainers competing for the country and particular benefits and incentives for those who have brought honor and recognition to the country by winning in international competitions;

WHEREAS, the City of Ormoc, in the past and in present has produced excellent athletes who triumphantly competed both in the national and international competitions, either as amateur or professional athletes;

WHEREAS, the City Government intends to give due honor and recognition for outstanding Ormoc City athletes, for those who contributed significantly to the history of sports in Ormoc City by garnering championship trophies and gold medals during local, national and international competitions in their respective events;

WHEREAS, the City Government wishes to institutionalize the "ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS, PAIRED OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFORE" and envisions the continuity of its implementation that will transcend the changes in the city's administration, until it is either repealed or amended in order to give way for a better sports program for the city;

WHEREFORE, on motion of SP Member Vincent L. Rama, Chairman of the Committee on Youth and Sports Development, severally seconded by SP Members Tomas R. Serafica, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Benjamin S. Pongos, Jr. and Mariano Y. Corro; be it

RESOLVED, to enact:

### **ORDINANCE NO. 056**

AN ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS, PAIRED OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFOR.

Be it ordained by the Sangguniang Panlungsod of Ormoc in Session duly assembled, that:

**SECTION 1. TITLE**. This Ordinance shall be known as the AN ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS, PAIRED OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFOR.

**SECTION 2. DECLARATION OF POLICY**. It is hereby declared a policy of the City of Ormoc to extend financial incentives to deserving athletes and coaches for having given honor to the City in various legitimate competitions in the fields of sports.

SECTION 3. DEFINITION OF TERMS. As used in this ordinance, the following terms or phrases shall be construed to mean:

- (a) Athletes refers a person trained to compete in sports involving physical strength, speed or endurance.
- (b) Coach- refers to an expert who trains a person or <u>team</u> of people in a particular sport.
- (c) Grantee refers to a Filipino Citizen athlete and coach who is qualified to avail of the privileges granted by this ordinance;
- (d) Individual players –refers to an athlete who participates in a sports which require a single player;
- (e) Group Sports- refers to a sports which requires three or more players in a team to compete against another team;
- (f) Sports Competitions- refer to various sports activities that are accredited or sanctioned by the following agencies, which include the following:
  - (f.1) National sports competitions:
    - Palarong Pambansa
    - Philippine National Youth Games (Batang Pinoy)

- National Games
- National Open
- Paralympics
- (f.2) For international and worldwide levels of sports competitions:
  - Olympic Games
  - World Championship of respective sports
  - Asian Games
  - South East Asia Games ( SEA Games)
  - A sports competition does not include exhibition games.

**SECTION 4. NUMBER OF GRANTEES**. The number of grantees under this program depends on how many will qualify with the requirements set forth in this ordinance.

# SECTION 5. QUALIFICATIONS AND REQUIREMENT OF GRANTEES To qualify as a grantee, athletes and coaches:

#### A. ATHLETES

1.QUALIFICATIONS: He/she must: be a bona-fide resident of the city of Ormoc for at least one (1) year and/or duly enrolled in any educational institution registered in the City of Ormoc and must have duly represented the City of Ormoc and has successfully won in the competitions she/he had participated;

### 2. REQUIREMENTS:

- 1) Must have submitted a letter of intent to the Ormoc City Sports Development Council of his/her participation and that said council must present their approval through a resolution signed by the majority of the members present for him/her to be considered as an official representative of the City and/or the country in a particular competition before the actual competition for records purposes;
- Re able to submit original and/or certified true copy of sertification and appropriate documentations that he/she participated and won first (1st), second (2nd) or third (3rd) places or gold, silver and bronze medals accordingly in a duly accredited sports, competitions in the national, international and worldwide levels;
- 3.) To claim the cash incentive, the above documents must be submitted by the Ormoc City Sports Development Council to the City Mayor's Office for approval.

# B. FOR COACHES -

He or she must be Filipino citizen, must submit to the Ormoc City Sports Development Council authentic certification from appropriate authority/agency and the grantee that he/she had been the official coach of the grantee for not less than 6 months.

# SECTION 6. AMOUNT OF INCENTIVES.

(a) For individual or pair sports competitions for the national or international levels of competitions, qualified grantees shall be entitled to receive the following cash incentives:

National Competitions:

1 <sup>st</sup> Placer / Gold Medalist	P3,000.00
2 <sup>nd</sup> Placer/ Silver Medalist	P2,000.00
3 <sup>rd</sup> Placer / Bronze Medalist	P1,000.00

International Competitions:

1 <sup>st</sup> Placer / Gold Medalist	P5,000.00
2 <sup>nd</sup> Placer/ Silver Medalist	P3,000.00
3 <sup>rd</sup> Placer / Bronze Medalist	P2,000.00

(b) For group sports, competitions, grantees shall be entitled to receive the following incentives for the whole group:

National Competitions:

1 <sup>st</sup> Placer / Gold Medalist	P15,000.00
2 <sup>nd</sup> Placer/ Silver Medalist	P10,000.00
3 <sup>rd</sup> Placer / Bronze Medalist	P 5,000.00

International Competitions:

1st Placer / Gold Medalist	P30,000.00
2 <sup>nd</sup> Placer/ Silver Medalist	P20,000.00
3 <sup>rd</sup> Placer / Bronze Medalist	P10,000.00

- (c) Only the qualified grantee/s shall be entitled to receive the financial incentive. The grant shall be non-transferrable.
- (d) Coaches of qualified grantees shall receive:
  - 1) Three thousand Pesos (Php3,000.00) cash incentive for national competitions.
  - 2) Five thousand Pesos (Php5,000.00) cash incentive for international competitions.

**SECTION 7. LIMITATION.** The financial incentive shall be given to the grantee/s for not more than once a year for every category of competition he or she competes/takes part of. In case of multiple medals in a single competition, the grantee shall be entitled to the medal with the higher incentive.

SECTION 8 FUNDS FOR THE PROGRAM. To carry out the provisions of this Ordinance, the necessary amount shall be taken annually from the Awards and Rewards Expenses of the City Mayor's Office Budget of the Sports Development Program starting CY 2018 and onwards.

**SECTION 9. SEPARABILITY CLAUSE**. The provisions of this ordinance are hereby declared separable and if one or more provisions are held invalid or unconstitutional, the remainder, or any provision hereof not affected, shall remain valid and effective.

**SECTION 10. REPEALING CLAUSE**. All Ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 11. EFFECTIVITY**. This Ordinance shall take effect immediately upon its approval and after compliance with publication and posting requirements pursuant to the relevant provisions of the Local Government Code of 1991.
