PREFATORY STATEMENT

WHEREAS, this Sanggunian enacted Appropriation Ordinance No. 2018-003 dated January 4, 2018, entitled: "AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FOR THE PURCHASE OF TWO (2) UNITS GRASS CUTTERS FOR THE CITY AGRICULTURE OFFICE (CAO) UNDER THE ACCOUNT AGRICULTURAL AND FORESTRY EQUIPMENT TO BE TAKEN FROM OUT OF THE REVERSION OF CY 2015 CONTINUING APPROPRIATION ACCOUNT - OTHER PROPERTY, PLANT AND EQUIPMENT OF SAME OFFICE";

WHEREAS, the subject appropriation ordinance is deemed a supplemental budget to the approved General Fund Annual Budget of the city for FY 2017 which provides funding for the proposed purchase of Two (2) units grass cutters as requested by the OIC-City Agriculturist, Ms. Maria Elena for the improvement of the City Agriculture Office' day to day operation;

WHEREAS, the Budget Operations Manual for LGUs issued by the Department of Budget and Management (DBM) provides that Supplemental Budgets should be authorized within the Fiscal Year covered by the Annual Budget hence, an Appropriation Ordinance covering a Supplemental Budget for the year 2017 can no longer be passed after December 31, 2017;

WHEREAS, Section 353 of the Local Government Code of 1991 provides that the official Fiscal Year of the LGUs shall be the period beginning with the 1<sup>st</sup> day of January and ending with the 31<sup>st</sup> day of December of the same year;

WHEREAS, considering that A.O No. 2018-003 which is a General Fund Supplemental Budget for CY 2017 was enacted on January 4, 2018 which date is beyond the Budget Year 2017, its enactment was found to be not in conformity with existing budgetary rules, laws and regulations thus, it is imperative that the same be repealed accordingly;



WHEREFORE FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


**SECTION 2.** This Ordinance shall take effect immediately after the compliance of the necessary publication and posting requirements as provided in the Local Government Code of 1991.

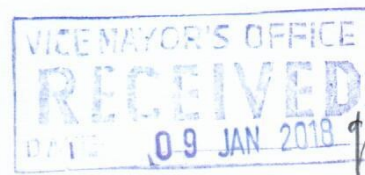

WHEREAS, the Office of the City Mayor forwarded an Endorsement dated December 18, 2017 to this august Body for consideration, relative to the request of Maria Elena A. Mendoza, Acting City Agriculturist, for reversion of funds from their savings of 2015 Capital Outlay: Other Property, Plant and Equipment in the amount of Fifty Thousand Pesos (P50,000.00) to Capital Outlay: Agricultural and Forestry Equipment for the purchase of Two (2) units of Grass Cutters;

WHEREAS, the proposed fund reversion is necessary to carry out the aforementioned purpose of the City Agriculture Office, which request is of great help for the improvement of its day to day operation, thus the need to be funded in order to achieve such intention;

That:

**SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET.** The sum of FIFTY THOUSAND PESOS (P50,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of Grass Cutters under the account Agricultural and Forestry Equipment of the City Agriculture Office to be taken from out of the 2015 Continuing Appropriation Other- Property, Plant and Equipment of same office.

**SECTION 2. EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
