

PREFATORY STATEMENT

WHEREAS, the City of Ormoc considers sports development as a priority program relative to its quest to provide a city where youths are more engaged to sports and public service rather than in vices;

WHEREAS, the City of Ormoc in reiterating the policy inculcated with RA 9064 which promotes excellence in sports and through sports by providing for the welfare of national athletes, coaches and trainers competing for the country and particular benefits and incentives for those who have brought honor and recognition to the country by winning in international competitions;

WHEREAS, in Ordinance No. 056, entitled AN ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS PAIRED OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFOR, the City has granted cash incentives to deserving athletes who excelled in sports competition in the past and the present year;

WHEREAS, the City of Ormoc intends to give due honor and recognition for outstanding Ormoc City Athletes, for those who contributed significantly to the history of sports in Ormoc City by garnering championship trophies and gold medals during local, national and international competitions in their respective events;

WHEREAS, the City Government, in view of the increase in the basic necessities for athletes and their training expenses, wishes to approve this amendatory ordinance in order to provide a sufficient amount which would aid athletes in their basic needs and training expenses;

WHEREFORE, on motion of SP Member Joan Marbie C. Simbajon, Chairman of the Committee on Youth and Sports Development, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang, Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente and Roiland H. Villasencio; be it

RESOLVED, to enact;

ORDINANCE NO. 014
(Series of 2019)

AN ORDINANCE AMENDING ORDINANCE NO. 056, S. 2018, ENTITLED: "AN ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS PAIRED OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFOR".

BE IT ORDAINED, by the 15th Sangguiang Panlungsod of Ormoc, that:

SECTION 1. Section 3 of Ordinance No. 056 is hereby amended to read as follows:

"SECTION 3. DEFINITION OF TERMS. As used in this ordinance, the following terms or phrases shall be construed to mean:

- (e) Group Sports – refers to a sports which requires two (2) or more players in a team to compete against another team

- World Championship of respective sports, sanctioned by the Philippine Sports Commission or the Philippines Olympics Committee."

SECTION 2. Section 6 of Ordinance No. 056 is hereby amended to read as follows:

"SECTION 6. AMOUNT OF INCENTIVES.

- (a) For individual or pair sports competitions for the national or international levels of competitions, qualified grantees shall be entitled to receive the following cash incentives:

International Competitions:

1 st Placer / Gold Medalist	P50,000.00
2 nd Placer/ Silver Medalist	P30,000.00
3 rd Placer / Bronze Medalist	P20,000.00

- (b) For group sports, competitions, grantees shall be entitled to receive the following incentives for the whole group:

International Competitions:

For 2-4 members:

1 st Placer / Gold Medalist	P50,000.00
2 nd Placer/ Silver Medalist	P30,000.00
3 rd Placer / Bronze Medalist	P20,000.00

With five (5) or more members:

1 st Placer / Gold Medalist	P80,000.00
2 nd Placer/ Silver Medalist	P50,000.00
3 rd Placer / Bronze Medalist	P30,000.00

(d) Coaches of qualified grantees shall receive:

- 2) Fifteen thousand Philippine Pesos (Php15,000.00) cash incentive for international competitions.

Provided that said coaches are duly accredited for such event by the Philippine Olympic Committee (POC) or Philippine Sports Commission (PSC) and/or organization affiliated thereto."

SECTION 3. A new Section 10 is hereby inserted after Section 9 of Ordinance No. 056, to read as follows:

"SECTION 10. RETROACTIVITY CLAUSE. The provisions of this Ordinance will be deemed retroactive and will include national and international competitions since the beginning of this quarter."

SECTION 4. Section 11 is hereby amended to read as follows:

"SECTION 11. REPEALING CLAUSE. All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly."

SECTION 5. Section 12 is hereby inserted to read as follows:


"SECTION 12. EFFECTIVITY. The said retroactivity shall take effect in accordance with the provisions of the Local Government Code of 1991, as amended."

ENACTED, December 10, 2019.


