WHEREAS, the Sangguniang Panlungsod ng Ormoc (this Sanggunian) was in receipt of an Indorsement from City Mayor Richard I. Gomez, dated November 23, 2018, requesting for an amendment of Ordinance No. 026, series of 2016 to include Care Giving Facilities, Continuing Care Retirement Communities and Retirement Villages in the list of the Investment Priority Areas and to exclude Shopping Malls from the list of Investment Priority Areas

WHEREAS, the amendment sought also responds to the request of the Ormoc City Chamber of Commerce and Industry, Inc. (ORCHAM) to consider the need of the rapidly aging population as opportunity and as investment priority to attract foreign investors to consider Ormoc City for their retirement facilities;

WHEREAS, the inclusion of retirement communities benefit the City as it will a broader variety of local employment opportunities beyond that of health sector which will eventually impact on local economic growth;

WHEREAS, the exclusion of shopping malls and other commercial centers in the IPA List are recommended because these businesses are not pioneering industries and considering further that there are already a good number shopping malls and other commercial centers which the Ormoc City Investment Incentives Board finds to be sufficient and fit for the economy of the City;

WHEREAS, this Sanggunian finds merit in the request to amend the IPA List of Ordinance No. 026 series of 2016;

ORDINANCE NO. 080

AN ORDINANCE **AMENDING** THE INVESTMENT PRIORITY AREAS (IPA) ANNEXED IN ORDINANCE 026 SERIES 2016, ENTITLED: "REVISED ORMOC CITY INVESTMENT INCENTIVES CODE OF 2016".

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Investment Priority Areas List (IPA LIST): ANNEX A of Ordinance No. 026 or the "Revised Ormoc City Investment Incentives Code of 2016" is hereby amended to read as follows:

SECTION 2. REPEALING CLAUSE. Any provision of ordinances, rule and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby modified, amended, and/or repealed accordingly.

SECTION 3. SEPARABILITY CLAUSE. Should any provision of this Ordinance be declared unconstitutional or invalid by any court of competent jurisdiction, the provisions that are not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon approval and after compliance with the requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
