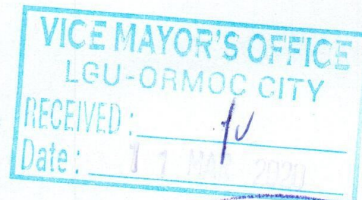

**EXPLANATORY STATEMENT**

WHEREAS, Article XIV, Section 19 (1) of the 1987 Constitution provides that "The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry";

WHEREAS, paragraph 2 of the above-quoted constitutional provision states further that "All educational institutions shall undertake regular sports activities throughout the country in cooperation with athletic clubs and sectors";

WHEREAS, Republic Act No. 6847 created the Philippine Sports Commission (PSC) under the Office of the President to carry out this constitutional mandate in coordination with the various government departments and private entities;

WHEREAS, Section 7 (m) of R.A. No. 6847 provides that the PSC shall encourage, promote, and sustain the creation and establishment of regional, provincial, municipal, and barangay or school district sports promotion and development councils composed of officials from the Department of Education, local government officials and representatives of the private sector that shall initiate, conduct and coordinate sports activities in their respective jurisdictions in order to ensure the implementation of the National Policy and Program of "SPORTS FOR ALL";

WHEREAS, Her Excellency President Gloria Macapagal-Arroyo issued Executive Order No. 438 on June 27, 2005 approving and adopting the Medium-Term Youth Development Plan (MTYDP) 2005-2010 which shall serve as the guiding framework for National Government Agencies (NGAs), Local Government Units (LGUs), and Non-Government Organizations (NGOs) in the formulation and implementation of youth-oriented programs and policies;

WHEREAS, in Sec. 3 of the above Executive Order, all LGUs are encouraged to adopt the MTYDP in their efforts to address the issues and concerns of the youth at the local level;



WHEREAS, Ormoc City in the past has produced excellent athletes who triumphantly competed both in the national and international competitions, either as amateur or professional athletes, to wit: Rey Evangelista and Robert Bolick, of the Philippine Basketball Association; Johnriel Casimero, a professional boxer and a three-weight world champion; Samuel German, Princess Arbilon and Michael Ver Anton Comaling, Modern Pentathlon athletes who got gold, silver and bronze medals during the 30<sup>th</sup> Southeast Asian Games; and Ormoc's very own, Mayor Richard I. Gomez, PhD, a gold medalist during the 2005 Southeast Asian Games for fencing (Men's Team Epee) and a gold medalist during the 2015 Asian Masters Fencing Championships, among other medals that he received in National and International Competitions.

WHEREAS, the above-mentioned athletes excelled in their respective sports events because of either the personal discipline or diligence of the athletes themselves, or the initiative and resourcefulness of the schools or entities they represent;

WHEREAS, the City of Ormoc can produce a steady supply of athletes for national and international competitions and can have a stronger and more successful sports program if only it will give the full support that the athletes need to boost their morale, maximize their potentials for victory, and inspire them to play their best for the city during competitions;

WHEREAS, the City Government of Ormoc seeks to establish a sports development program in order to discover and develop fresh would-be athletes from the primary and secondary levels who will someday represent competently the City of Ormoc in the national level competitions, or who will become national athletes and will bring honor and glory for the city;

WHEREAS, the city's sports development council and sports office aims to contribute to the National Sports Development Program;

WHEREAS, the City Government desires to grant scholarships and assistance to those who will be in the city's Pool of Players, and especially scholarship privileges in the tertiary level and other incentives for those who will bring home for the city the highest honors in regional, national, and international competitions;

WHEREAS, it is imperative for the City Government to provide, upgrade and maintain its sports facilities which is at par with international standards that will give the capability to host citywide, provincial, regional, and national competitions;

WHEREAS, the City Government also desires to upgrade, enhance and professionalize the skills and capabilities of the local coaches, trainers, and referees and provide them with incentives and benefits that will correspond to their efforts in contributing to the success of the city's sports program;

WHEREAS, the City Government intends to give due honor and recognition for outstanding Ormoc athletes and coaches by establishing a Hall of Fame for those who contributed significantly to the history of sports in Ormoc by garnering championship trophies and gold medals during regional and national competitions in their respective events;

WHEREAS, the City Government enacted Ordinance No. 067, establishing the sports policy and program of Ormoc City, creating the Ormoc City Sports Council and Ormoc City Sports Office, prescribing the compositions thereof, defining the duties and functions thereto, and appropriating funds therefore;



WHEREAS, the created Ormoc City Sports Council suffered inherent limitations that hinders the attainment of the objectives of the City Government thereby necessitates the abolition thereof and creation of a sports commission that will have more direct and adequate power on the management of all government sports facilities and regulation of all sports activities of Ormoc City.

NOW, THEREFORE, on motion of SP Member Jasper M. Lucero, Chairman on Committee of Good Government & Oversight together with SP Member Nolito M. Quilang, Member, Committee on Good Government & Oversight and SP Member Joan Marbie C. Simbajon, Chairman, Committee on Youth & Sports Development, severally seconded by SP Members Tomas R. Serafica, Eusebio Gerardo S. Penserga, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Lalaine A. Marcos and Esteban V. Laurente; be it

RESOLVED, to enact:

**ORDINANCE NO. 2020-018**  
**(Series of 2020)**

**AN ORDINANCE CREATING THE ORMOC CITY SPORTS COMMISSION AND REVISING FOR THIS PURPOSE ORDINANCE NO. 067, OTHERWISE KNOWN AS "AN ORDINANCE ESTABLISHING THE SPORTS POLICY AND PROGRAM OF ORMOC CITY, CREATING THE ORMOC CITY SPORTS COUNCIL AND ORMOC CITY SPORTS OFFICE, PRESCRIBING THE COMPOSITIONS THEREOF, DEFINING THE DUTIES AND FUNCTIONS THERETO, AND APPROPRIATING FUNDS THEREFOR".**

BE IT ENACTED by the Fifteenth Sangguniang Panlungsod ng Ormoc, That:

**SECTION 1. TITLE** - This ordinance shall be known as the "ORMOC CITY SPORTS COMMISSION ORDINANCE".

**SECTION 2. DECLARATION OF POLICY** - The City of Ormoc hereby declares as a policy that Sports shall be pursued to carry out a constitutional mandate of promoting well-rounded personality among its constituents, promoting healthy lifestyles especially among the youth and foster physical fitness, self-discipline, teamwork and excellence for the development of a healthy and alert citizenry. The City Government of Ormoc also aims to make sports a pillar of the city tourism program aiming to boost the potentials of Ormoc City as a destination and making the City a site of various sports events.

It is also a policy of Ormoc City to implement grassroots sports program and carry out in the community's physical fitness activities, recreation program, projects and activities and to pursue the goals and strategies of Philippine Sports Commission.

**SECTION 3. THE ORMOC CITY SPORTS PROGRAM**- The Ormoc City Sports Program is hereby established to carry out the declared policy and boost the potentials of Ormoc City as a producer of outstanding athletes in various fields of sports. The Ormoc City Sports Program shall have the following components, to wit:

- a. Grassroots Sports to put in place sports programs at the barangay level utilizing a portion of SK budget to sports program;
- b. Inter-barangay or inter district or city wide sports events;



- d. Coordinate and assist the Department of Education and the Colleges of the City to integrate their entire sports program and be directed to achieve the vision of developing career and national athletes.
  - e. Promulgate or adopt rules and regulations governing the sports tournaments, leagues and other related activities directly promoted and supervised by the commission.
  - f. Develop sports competitions/tournaments in the different barangays in the City of Ormoc and provide for the appropriate uniforms and prizes.
  - g. Conduct basic and applied research on sports development and other related activities.
  - h. Invite and engage the services of consultants and experts for the various form of sports to train our own athletes, local coaches, trainers, and referees on the standard rules and techniques for their respective events and improve their performances, both during trainings and competitions.
  - i. Form the City's pool of players and determine who are to be accepted in the pool.
2. Maintain, administer and supervise the management of existing sports facilities of the City Government located in Ormoc City Central School and New Ormoc City National High School and any future sports facilities or complex of the city which includes but not limited to:
- a. Promulgate Rules and regulations on the use of sports facilities.
  - b. Recommend to the Sanggunian the appropriate fee for the use of the sports facilities and equipment for the Sanggunian to pass the corresponding Resolution or Ordinance as the case maybe.
  - c. Plan out, develop and maintain a new Sports Complex, Recreational Facilities, Playgrounds, and attainment of the plan to build modern sports complex for major national sports competition which shall serve as training center/venue for the athletes.
  - d. Subject to the approval of the concerned authority, use all available vacant school yards and/or public playgrounds, barangay halls, and other public facilities of the City of Ormoc suitable for the activities organized by the commission.
3. Provide incentives to athletes, coaches, trainers, consultants, referees, and other persons or entities involve in supporting the sports development program, the following but not limited to:
- a. Provide athletes and coaches technical assistance, exposures and access to high training standards by top-caliber athletes and mentors.
  - b. Formulate the amount and scheme of compensation for coaches, trainers and referees, either employed permanently or temporarily.
  - c. Formulate and provide the amount and schemes of incentives to athletes who are recruited in the pool of athletes and those who are qualified to represent the City of Ormoc for EVRAA, PALARO, Batang Pinoy and other government sponsored sports events.
  - d. Propose to the Sanggunian the sports scholarship program to all deserving athletes who excel in their respective sports event and consequently bring honor for the city through their participation in high-level competitions like the Eastern Visayas Regional Athletic Association (EVRAA) Meet, the Palarong Pambansa and the Batang Pinoy.
  - e. Receive applications for scholarship through Sports, evaluate and recommend to the City Mayor who shall be qualified to be granted scholarship program through sports.



- f. Receive donations and sponsorships from different persons and entities to help finance the various programs and activities.
- 4. Formulate annual sports development plan, specifying programs, projects and activities including sports events, which include but not limited to:
  - a. Review and approve the project procurement plan submitted by the Ormoc City Sports Office.
  - b. Submit to the City Mayor the annual budget for all expenses in carrying out the annual sports development program, all sports activities, trainings, incentives, prizes, as well as all administrative expenses of the commission, which shall form part of the annual investment plan.
- 5. Regulate all sports tournament conducted within Ormoc City not sponsored by the City, DepEd or the Philippine Sports Commission, which includes but not limited to:
  - a. Issue clearances to organizations, associations or any persons that apply for a sports tournament in Ormoc City either in a particular Barangay or Citywide tournament.
  - b. Issue a cease and desist order against any persons, associations, or organizations that conducts tournament without the requisite clearance from the commission.
  - c. Accredite any sports association, organizations or clubs based and operating within Ormoc City.
  - d. Formulate rules and regulations regarding the accreditations of sports associations.

**SECTION 3. CREATION OF ORMOC CITY SPORTS OFFICE-** To fully implement this ordinance, a separate section under the Office of the City Mayor shall be created to handle the administrative and technical responsibilities of the Ormoc City Sports Program. The Ormoc City Sports Office shall perform the following functions:

- a. As maybe directed by the Commission, formulate a project procurement management plan specifying the sports equipment and other facilities, supplies and materials needed for the sports activities and submit the same to the Commission for approval;
- b. Spearhead the effective implementation of the comprehensive city sports development program including the conduct of sports events in the city;
- c. Coordinate with government, whether local and national, and the non-government sectors for the implementation of the sports program;
- d. Propose, organize and handle capability building activities for the sports associations and other stakeholders of the sports program;
- e. Create and maintain a databank of the vital information needed for planning and policy formulation purposes;
- f. Serve as secretariat of the Ormoc City Sports Commission and other bodies that maybe assigned to the office for coordination by an Ordinance;
- g. Submit annual report and financial statement of the City Sports Program to the Commission and the Office of the City Mayor;
- h. Submit to the Commission periodic monitoring and status reports of the various sports projects and events; and
- i. Propose to the Commission guidelines, implementing rules and regulations regarding the financial assistance and/or incentives to athletes.



- f. Receive donations and sponsorships from different persons and entities to help finance the various programs and activities.
- 4. Formulate annual sports development plan, specifying programs, projects and activities including sports events, which include but not limited to:
  - a. Review and approve the project procurement plan submitted by the Ormoc City Sports Office.
  - b. Submit to the City Mayor the annual budget for all expenses in carrying out the annual sports development program, all sports activities, trainings, incentives, prizes, as well as all administrative expenses of the commission, which shall form part of the annual investment plan.
- 5. Regulate all sports tournament conducted within Ormoc City not sponsored by the City, DepEd or the Philippine Sports Commission, which includes but not limited to:

  - b. Issue a cease and desist order against any persons, associations, or organizations that conducts tournament without the requisite clearance from the commission.
  - c. Accredite any sports association, organizations or clubs based and operating within Ormoc City.
  - d. Formulate rules and regulations regarding the accreditations of sports associations.

**SECTION 3. CREATION OF ORMOC CITY SPORTS OFFICE-** To fully implement this ordinance, a separate section under the Office of the City Mayor shall be created to handle the administrative and technical responsibilities of the Ormoc City Sports Program. The Ormoc City Sports Office shall perform the following functions:

- a. As maybe directed by the Commission, formulate a project procurement management plan specifying the sports equipment and other facilities, supplies and materials needed for the sports activities and submit the same to the Commission for approval;
- b. Spearhead the effective implementation of the comprehensive city sports development program including the conduct of sports events in the city;
- c. Coordinate with government, whether local and national, and the non-government sectors for the implementation of the sports program;
- d. Propose, organize and handle capability building activities for the sports associations and other stakeholders of the sports program;
- e. Create and maintain a databank of the vital information needed for planning and policy formulation purposes;
- f. Serve as secretariat of the Ormoc City Sports Commission and other bodies that maybe assigned to the office for coordination by an Ordinance;
- g. Submit annual report and financial statement of the City Sports Program to the Commission and the Office of the City Mayor;
- h. Submit to the Commission periodic monitoring and status reports of the various sports projects and events; and
- i. Propose to the Commission guidelines, implementing rules and regulations regarding the financial assistance and/or incentives to athletes.



- j. Formulate and endorse to the Commission for approval rules and regulations on the use of sports facilities.
- k. Organize sports clinics, trainings and seminars by bringing certified sports facilitators.
- l. Supervise the different sports programs of the City.
- m. Organize a coach's pool, sports officials' pool and an athlete's pool for continuous training and development.
- n. Perform other functions that may be assigned to it by an ordinance, the City Sports Commission or by the City Mayor from time to time.

**SECTION 9. ORGANIZATIONAL STRUCTURE OF THE ORMOC CITY SPORTS OFFICE** – The Ormoc City Sports Office shall be composed of the following units:

- a. GRASSROOTS SPORTS UNIT- to plan and implement sports activities at the barangay level ensuring proper coordination with the Sangguniang Kabataan and the Barangay Councils for the successful conduct of sports activities. This section shall also initiate and organize inter-barangay or inter-district or city wide sports events;
- b. SPORTS COMPETITIONS UNIT- this section shall work with the Department of Education in preparing the athletes to regional and national meet and work with other sports associations in preparing players that will compete in other national and international sports competitions; and
- c. CITY SPORTS EVENTS UNIT- Coordinate the sports events during the fiesta, charter day and other occasions where Ormoc City is designated to host special sports competition, and exhibition.

**SECTION 10. CREATION OF SPORTS DEVELOPMENT OFFICER III POSITION AND TRANSFER OF SPORTS DEVELOPMENT OFFICER I POSITION TO THE ORMOC CITY SPORTS OFFICE**– There is hereby created a Sports Development Officer III position with Salary Grade 18 who shall serve as head of the Ormoc City Sports Office.

The Sports Section under the Public Affairs and Information Assistance Office (PAIAO) is hereby abolished and a filled up position of Sports Development Officer I of Salary Grade 10 shall be transferred to the newly created Ormoc City Sports Office to provide administrative and technical assistance to the said office.

**SECTION 11. SCRAPPING OF EXISTING POSITIONS**– The following unfilled positions shall be abolished to fund the creation of one (1) Sports Development Officer III position:

**SECTION 12. QUALIFICATION OF THE SPORTS DEVELOPMENT OFFICER III**– The Sports Development Officer III shall possess the following qualifications:

- Education : Bachelor's Degree
- Experience : Two (2) years of relevant experience
- Training : Eight (8) hours of relevant training
- Eligibility : A Professional Civil Service Eligible or its equivalent
- Residency : A Filipino citizen, bona fide resident of Ormoc City
- Others : Good moral character



**SECTION 13. DUTIES AND FUNCTIONS OF THE SPORTS DEVELOPMENT OFFICER III-** The Sports Development Officer III shall have the following functions and duties:

- a. To execute the policies, rules and regulations promulgated by the Commission;
- b. To spearhead the implementation of all the plans of the Commission;
- c. To oversee the activities of the sports organizations accredited with the Ormoc City Sports Commission;
- d. To serve as liaison officer of the City Government with other government agencies, sports associations and other organizations implementing sports programs;
- e. To facilitate the conduct of researches on new programs concerning sports development;
- f. To serve as the Secretary of the Commission and perform the following duties:
  1. To prepare the agenda and record of the minutes of the meetings of the Commission;
  2. To submit a Quarterly Report to the Commission;
  3. To submit an Annual Report to the Commission furnishing a copy to the City Planning within 30 days after the close of each Calendar Year;
  4. To keep and be responsible of all the records of the Commission;
  5. To carry out and implement the agreements/contracts executed with the Commission;
- g. To perform such other functions as maybe assigned by law, ordinance, by the City Mayor or the City Sports Commission.

**SECTION 14. DUTIES AND FUNCTIONS OF THE SPORTS DEVELOPMENT OFFICER I-** The Sports Development Officer I shall perform the following duties and functions:

- a. Establish and maintain the roster of officers and members of the different sports associations in the City and maintain a databank of players or athletes and their ranking. The databank shall include all pertinent data and information regarding all sports and games.
- b. Assist in planning, initiating, facilitating and coordinating sports and games in all levels, i.e. local, provincial, regional and international.
- c. Create public awareness, through multi-media channels on the implemented sports programs and activities.
- d. Assist in addressing issues and public concerns related to the sports being disseminated and games being conducted.
- e. Take charge in the dissemination and forwarding of information to specific associations/clubs, barangays and individuals who are involved in sports programs/ activities.
- f. Develop and maintain systematic data-based records and documentation on trainings.
- g. Assist in developing, recommending, initiating, coordinating and implementing a more effective and systematic training program for the commission's staff, sports associations' mentors, coaches and players.
- h. Assist in creating a pool of sports trainers in the different fields of sports.
- i. Perform other duties and functions that may be assigned by the Head of Office from time to time.



**SECTION 15. OTHER SUPPORT STAFF OF THE OFFICE-** For the effective operations of the office, the City Mayor may augment the personnel of the said office through any or a combination of the following options:

- a. Designation or assignment of personnel on concurrent capacities with their existing positions;
- b. Reassignment of personnel of the city to the Ormoc City Sports Office; and
- c. Part-time detail of existing personnel to the Ormoc City Sports Office.

**SECTION 16. BUDGETARY AND FINANCIAL REQUIREMENT-** The appropriation necessary to cover the cost for the newly created position shall be charged to the abolished position of the City Hospital and amount necessary to cover the cost of the operations of the Commission and said Sports Office for the CY 2018 shall be taken from the current funds of the City Mayor's Office. For the succeeding years, the Appropriation for the newly created position, operations of the Ormoc City Sports Commission, salaries, incentives, and the operations of the Ormoc City Sports Office shall be included in the Annual Budget of the said office.

**SECTION 17. BARANGAY SPORTS DEVELOPMENT PROGRAM-** Every barangay in Ormoc City through the Chairman of the Committee on Youth and Sports shall coordinate with the Ormoc City Sports Office to develop a sports development plan giving focus on the potentials of the barangay to excel in certain sports. The projects shall be included in the annual investment plans of the barangays.

All Barangays in Ormoc City shall submit Annual Sports Development Plans and Annual Procurement Plan to the Ormoc City Sports Office before December 31 of each year to ensure proper coordination with the Council and for possible counterpart funding. The said plan shall indicate specific funding requirements and be accompanied by a barangay resolution indicating the approval of the Barangay Council and SK Council resolution if funds to be used come from the 10% budget allocation to the youth programs.

The preparation of a Barangay Annual Sports Development Plan shall not prejudice the other programs and projects of the youth and it is therefore necessary that the SK Council and Barangay Council shall ensure a balance in the allocation of the 10% budget for all youth programs.

The Ormoc City Sports Council shall prepare the planning guidelines and the necessary forms for the preparation of the Annual Sports Development Plan.

**SECTION 18. IMPLEMENTATION OF SPORTS DEVELOPMENT-** The ORMOC CITY SPORTS OFFICE shall be responsible for the implementation of the city's Comprehensive Sports Development Program formulated by the Ormoc City Sports Commission and act as the SECRETARIAT of the Commission.

**SECTION 19. MAINTENANCE STAFF-** There shall be sufficient maintenance staff and utility personnel of the commission responsible for the maintenance of all sports facilities of the City under the direct supervision of the head of the Ormoc City Sports Office which shall be furnished by the City Mayor to the Commission, either casual and/or JO employees. However, maintenance staff that require skills such as the maintenance of the swimming pool should be employed as casual.

**SECTION 20. IMPLEMENTING GUIDELINES-** The Office of the City Mayor with the Ormoc City Sports Office, City Administrator, City Treasurer, and the City Budget Officer, shall promulgate implementing guidelines for effective implementation of this ordinance in which such implementing guidelines shall be deemed part of this ordinance.



**SECTION 21. REMUNERATION**– The chairperson, members and secretary of the commission shall be entitled to an honorarium of One Thousand Pesos (Php1,000.00) per meeting but not to exceed TWELVE THOUSAND PESOS (Php12,000.00) in a year.

**SECTION 22. SCHOOL SPORTS PROGRAM**– The Ormoc City Schools Division Office, in consultation and cooperation with Ormoc City Sports Commission (OCSC), shall formulate a yearly sports program for all public and private schools in the primary and secondary levels for the following purposes:

- a. Instill sports awareness among the learners and students.
- b. Foster the value of self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry.
- c. Ensure a ready supply of competitive athletes that will represent the City during provincial, regional, and national competitions.
- d. Provide the best alternative to using illegal drugs and other vices.

**SECTION 23. INCENTIVES FOR COACHES, TRAINERS, AND REFEREES** – The commission shall provide incentives to Local coaches, trainers, and referees from the City of Ormoc who shall be compensated on the following schemes but not limited to:

- a. Those that are employed permanently/temporarily, either as government or as private employees, nevertheless, can render their services as coaches, trainers, or referees after office hours or during weekends shall be paid on an honorarium basis.
- b. Those who shall serve as coaches, trainers, and referees on a full-time basis shall be paid as full-time casual employees of the City Government with corresponding benefits that are due to government employees.

**SECTION 24. BENEFITS AND INCENTIVES FOR ATHLETES** – The commission shall provide athletes from various sports events, who are in the city's Pool of Players, the following benefits and incentives, subject to COA rules and regulations, but not limited to:

DURING IN-TRAINING

- a. Subsistence Allowance
- b. Complete Set of Uniforms and shoes
- c. Sports Equipment and Supplies
- d. Vitamins
- e. Free Health Care Services
- f. Social Security Benefits

DURING COMPETITION

- a. Food
- b. Subsistence Allowance
- c. Complete Set of Uniforms and shoes
- d. Sports Equipment and Supplies
- e. Vitamins
- f. Free Health Care Services
- g. Social Security Benefits
- h. Travel allowance

**SECTION 25. BENEFITS AND INCENTIVES FOR STUDENT ATHLETES WHO ARE QUALIFIED TO COMPETE FOR EVRAA AND PALARO**– Student Athletes who are qualified to compete for EVRAA AND PALARO as certified by the SDS of DepEd, Ormoc City Division, are given the following benefits and incentives, subject to COA rules and regulations, but not limited to:



**DURING IN-TRAINING**

(Starting one month before the proposed date of competition)

- a. Food
- b. Vitamins
- c. Free Health Care Services
- d. Training allowance (for qualified Ormoc Palaro athletes only)

**DURING COMPETITION**

- a. Food
- b. Vitamins
- c. Free Health Care Services
- d. Complete set of uniform and shoes

**SECTION 26. FUNDING FOR THE IMPLEMENTATION OF THE SPORTS PROGRAM**– Funding for this program shall come from the city's general fund, SEF, sponsorships, and donations from outside sources.

Sponsorships and/or donations from outside sources shall be deposited on a trust fund specifically for the purpose of funding the implementation of the sports program and/or upon the request of the donor/sponsor.

**SECTION 27. HALL OF FAME FOR ORMOC CITY SPORTS**– The City Government shall establish a Hall of Fame for Ormoc City Sports to honor and give due recognition for athletes and/or coaches, both in the past and in the generations to come, who gave/will give honor and glory to Ormoc City in regional, national and international competitions for bringing home championship trophies and/or gold medals in their respective sports events. This includes those Ormocanon athletes who have represented the Country in International sports competitions such as SEA Games, ASIAN Games World Championships and the Olympics.

**SECTION 28. PENALTY** – Any person organizing and conducting sports tournament without obtaining clearance from the Commission except government, intra-company and intra-school sponsored tournaments, shall be liable to pay fine in the amount of One Thousand Five Hundred (P1,500.00) Pesos. For second and succeeding offense, the offender shall be liable for imprisonment of not exceeding one (1) month and/or fine of Three Thousand (P3,000) Pesos. However for first offense, the offender may opt to pay administrative fine of same amount to avoid prosecution.

**SECTION 29. REPEALING CLAUSE** - All Ordinances, Executive Orders, and all other local rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

**SECTION 30. SEPARABILITY CLAUSE** – Should any part or provision of this Ordinance be declared invalid or unconstitutional, any part or provision not affected thereby shall continue to be in full force and effect.

**SECTION 31. EFFECTIVITY**– This Ordinance shall take effect immediately following compliance with the publication requirements under the Local Government Code of 1991.
