PREFATORY STATEMENT

WHEREAS, the World Health Organization (WHO) has declared COVID-19 as a pandemic;

WHEREAS, Article 2, Section 15 of the 1987 Philippine Constitution in relation to Section 16 of the Local Government Code (RA 7160), the LGUs are expressly mandated and charged with the promotion of health and safety within their respective territorial jurisdictions. As such, they must take the lead in the prevention, mitigation, preparedness for, and containment of, COVID-19 at the local level;

WHEREAS, on March 8, 2020 the President Duterte issued Presidential Proclamation No. 922 declaring the country in a State of Public Health Emergency and later on March 12, 2020 the President issued Proclamation 929 placing the entire Philippines under the state of calamity in relation to COVID-19;

WHEREAS, further President Rodrigo Duterte declared an "Enhanced Community Quarantine" over the entire Luzon including Metro Manila as part of a continuous push to contain the spread of the COVID-19;

WHEREAS, the City Government of Ormoc adopted strings of measures through the issuance of EOs' placing the City under "General Community Quarantine" which includes among others regulating the entry of individuals coming to Ormoc by land, air and sea travel to limit the movement of individuals to lessen the exposure to risks associated with the COVID-19, strict home quarantine is implemented in all households, closure of non-essential businesses, and only business providing essential goods and services are allowed to open;

WHEREAS, the community quarantine implemented by the City Government of Ormoc has greatly affected the City and cause disruption to the local economy as residents are strictly advised to stay at home and some business establishments were forced to shut down;

WHEREAS, Section 192 of RA 7160 otherwise known as the Local Government Code of 1991, provides that Local Government Units may, through a duly approved ordinance, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary. The extension of time to accept payments of taxes or charges falls within the purview of reliefs;

WHEREAS, in DTI Memoradum Circular No. 20-12 s. 2020 issued on April 4, 2020, in relation to RA 11469 otherwise known as the "Bayanihan to Heal as One Act" provides the a minimum of thirty (30) days grace period shall be granted on commercial rentals on commercial rents without incurring interest, penalties, fees or other charges;

WHEREAS, the present circumstances and events brought about by COVID-19 pandemic make it necessary and appropriate the granting of extension of time for accepting payments of local taxes and charges by the City Government of Ormoc from the taxpayers, stallholders and lessors of local government properties without incurring interest, penalties, fees or other charges.

WHEREAS, the foregoing premises considered, this Sanggunian finds great merit in the City Mayor's request intended for the benefit of the City and to the community as a whole;

WHEREFORE, on joint motion of SP Member Jasper M. Lucero, Chairman, Committee on Economic Enterprise and SP Member Tomas R. Serafica, Chairman, Committee on Ways and Means, severally seconded by SP Members Benjamin S. Pongos, Jr., Vincent L. Rama, Peter M. Rodriguez, Gregorio G. Yrastorza III, Lalaine A. Marcos, Joan Marbie C. Simbajon and Roiland H. Villasencio; be it

RESOLVED AS IT IS HEREBY RESOLVED, to enact:

ORDINANCE NO. 021 (Series of 2020)

AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENTS OF LOCAL TAXES AND CHARGES WITHOUT INCURRING INTERESTS, PENALTIES OR SURCHARGES DUE TO THE NEW CORONAVIRUS INFECTIOUS DISEASE (COVID-19) PANDEMIC.

BE Π ENACTED by the 15th Sangguniang Panlungsod in its Regular Session duly assembled, that:

SECTION 1. The payment for Real Property Taxes due and payable to the City Government of Ormoc for the current year which is due to be paid on or before March 31, 2020 can be paid two (2) months after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties or surcharges.

SECTION 2. The 2nd Quarter payment for Business Taxes due and payable to the City Government of Ormoc for the current year which is due to be paid on or before April 20, 2020 can be paid two (2) months after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties or surcharges.

SECTION 3. The payment for Franchise Taxes of Privately Owned Terminals due and payable to the City Government of Ormoc for the current year which is due to be paid on or before April 20, 2020 can be paid two (2) months after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties or surcharges.

SECTION 4. The monthly payment for Amusement Taxes of Cinemas due and payable to the City Government of Ormoc for the current year which is due to be paid on or before every 10th day of the month during the period of the General Community Quarantine can be paid two (2) months after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties or surcharges. The taxpayers can still avail of the applicable discounts.

SECTION 5. The payment of monthly Rentals for Terminal and Market Stalls for the current year which is due to be paid on or before every 3rd day of the month, the Rentals for Superdome Commercial Spaces for the current year which is due to be paid on or before every 7th day of the month, the Rentals for the Old Legislative Building for the current year which is due to be paid on or before every 5th day of the month to the City Government of Ormoc during the period of the General Community Quarantine can be paid in the following:

- a. For Micro Enterprises within six (6) months after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties, fees or other charges.
- b. For Small Enterprises within two (2) months after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties, fees or other charges.
- c. For Medium Enterprises within two (2) menths after the lifting of the declaration of the state of health emergency or state of calamity whichever comes later without interest, penalties, fees or other charges.

For purposes of this Ordinance and in accordance with RA 6977, the business activity or enterprise shall be categorized as follows:

Micro : not more than P3,000,000 Small : P 3,000,001 - P15,000,000 Medium : P15,000,001 - P100,000,000

SECTION 6. REPEALING CLAUSE – All Ordinances and or Resolutions, or portions thereof, inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE – If for any reason any provision of this Ordinance is declared unconstitutional or invalid by any competent court, the other parts or provisions hereof which are not affected thereby shall continue in full force and effect.

SECTION 8. EFFECTIVITY - This Ordinance shall take effect immediately upon approval and after compliance with necessary posting and publication requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
