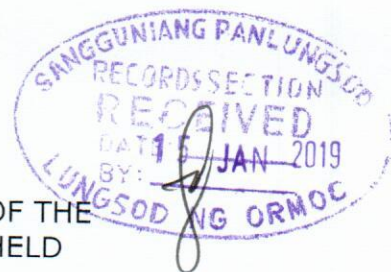

**RESOLUTION NO. 2019-004**

**A RESOLUTION INTERPOSING NO OBJECTION FOR THE  
CONSTRUCTION OF BYPASS/DIVERSION ROADS,  
ORMOC CITY DIVERSION ROAD (BRGY. SAN JUAN -  
LAO - NAUNGAN) INCLUDING BRIDGES AND SLOPE  
PROTECTION (PACKAGE A, B, C, D, E, F, G).**

WHEREAS, the City Mayor Richard I. Gomez through an Indorsement Letter dated April 5, 2018 forwarded to this August Body for consideration the request of District Engineer Lino Francisco C. Gonzalez for the issuance of a Resolution Interposing No Objection for the project, entitled: "Construction of Bypass/Diversion Roads, Ormoc City Diversion Road (Brgy. San Juan-Lao-Naungan) including Bridge and Slope Protection (Package A, B, C, D, E, F, G), Leyte" with an initial project cost of P1,300,000,000.00 funded under GAA 2018 Infrastructure Program;

WHEREAS, the immediate subject matter of this Resolution is the construction of the Bypass/Diversion Roads traversing through Barangays San Juan, Lao and Naungan which is 4.3 km in length, widening the roads into a 4-lane, and with the construction of three (3) units 2-lane bridges with an initial project cost of P1,300,000,000.00, more than P800,000,000.00 of which is implemented by the DPWH-Regional Office, and the P500,000,000.00 is implemented by the 4<sup>th</sup> Leyte Engineering District Office (4<sup>th</sup> LED);

WHEREAS, a Sangguniang Panlungsod Resolution Interposing No Objection for the aforementioned project is required by the Environment Management Bureau (EMB) under the Department of Environment and Natural Resources (DENR) for the processing of permits of the project;



WHEREAS, the DPWH, considering the flooded areas in some part of the barangays, have utilized their post typhoon assessments in the planning and design of the project by installing box culverts to mitigate flooding which will not aggravate the condition of the barangays;

WHEREAS, the DPWH conducted public consultation with the residents of Barangays San Juan, Lao and Naungan in relation to the aforementioned project and was found out by the residents to be favourable and beneficial to the Barangays;

WHEREAS, the Sangguniang Barangay of Barangays San Juan, Lao and Naungan recognized the aforementioned project's contribution to the economic activities redounding to the upliftment of the quality of life of the stakeholders who will benefit from it;

WHEREAS, the Sangguniang Barangay of Barangays San Juan, Lao and Naungan issued Barangay Resolutions expressing support and no objection of the aforementioned project, copies of which are hereto attached as Annexes "A", "B", and "C", respectively, and made integral parts hereof;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the Office of the City Mayor, finds that the project is beneficial to the stakeholders and residents of Barangays San Juan, Lao and Naungan and to the City of Ormoc and therefore, favorably endorses and interposes no objection to the implementation of the project, entitled: "Construction of Bypass/Diversion Roads, Ormoc City Diversion Road (Brgy. San Juan-Lao-Naungan) including Bridges and Slope Protection (Package A, B, C, D, E, F, G), Leyte;"
