**A RESOLUTION APPROVING AND GRANTING
AUTHORITY TO THE CITY GENERAL SERVICES
OFFICER TO PURCHASE TWO (2) UNITS OF SERVICE
VEHICLE IN THE AMOUNT OF THREE MILLION
PHILIPPINE PESOS (PHP3,000,000.00).**

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated December 19, 2018 respectfully endorsing the request of Engr. Domardoni C. Cayanong, City General Services Officer, for the passage of a Resolution granting authority to purchase two (2) units of Service Vehicle for the total amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00);

WHEREAS, the requested vehicles shall be used by the City General Services Office to continually provide services and assistance to the public, in addition to the existing line of vehicles that are usually used for vehicle burial assistance which greatly limits the mobility of the City General Services Office in serving the public;

WHEREAS, the City Accountant, City Budget Officer, and the City Treasurer issued a Certificate of Availability of Funds dated December 18, 2018 stating therein that the General Services Office (GSO) has available fund(s) for the purchase of the aforementioned vehicle in the amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) to be sourced from CY 2018 General Fund (Capital Outlay for Motor Vehicles), a copy of said certification is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;

WHEREFORE, on motion by SP Member Mario M. Rodriguez, Chairman of the Committee on Finance and Appropriation, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Gregorio G. Yrastorza III; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION APPROVING AND GRANTING AUTHORITY TO THE CITY GENERAL SERVICES OFFICER TO PURCHASE TWO (2) UNITS OF SERVICE VEHICLE IN THE AMOUNT OF THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00);
