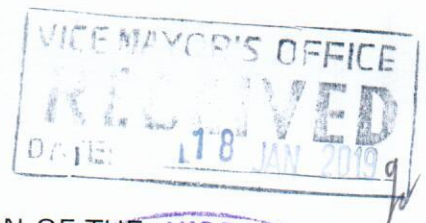

**RESOLUTION NO. 2019-016**

**A RESOLUTION DECLARING BARANGAY TAX ORDINANCE NO. 2018-001 OF THE SANGGUNIANG BARANGAY OF BARANGAY COGON, ORMOC CITY, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2015-004 ENTITLED "AN ORDINANCE AMENDING SOME PROVISION IN ACCORDANCE OF BARANGAY ORDINANCE NO. 2007-03 PER SANGGUNIANG PANLUNGSOD RESOLUTION 2007-101 ENTITLED "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMIT AND OTHER CHARGES", AND BARANGAY TAX ORDINANCE NO. 002-2018 OF THE SAME BARANGAY, ENTITLED: "AN ORDINANCE IMPOSING AND FIXING FEES FOR THE USE OF BARANGAY FACILITIES" UNDER REVIEW, TO BE NOT INCONSISTENT WITH EXISTING LAWS AND CITY ORDINANCES AND INTERPOSING NO OBJECTIONS TO THE IMPLEMENTATION THEREOF.**

WHEREAS, this Sanggunian was in receipt of a copy of Barangay Tax Ordinance No. 2018-001, from the Sangguniang Barangay of Cogon, this City, entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2015-004 ENTITLED "AN ORDINANCE AMENDING SOME PROVISION IN ACCORDANCE OF BARANGAY ORDINANCE NO. 2007-03 PER SANGGUNIANG PANLUNGSOD RESOLUTION 2007-101 ENTITLED "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMIT AND OTHER CHARGES", a copy of said Tax Ordinance is hereto attached as Annex "A" and made an integral part hereof;



WHEREAS, this Sanggunian was also in receipt of a copy of Barangay Tax Ordinance No. 002-2018, from the Sangguniang Barangay of Cogon, this City, entitled: "AN ORDINANCE IMPOSING AND FIXING FEES FOR THE USE OF BARANGAY FACILITIES", a copy of said Tax Ordinance is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, the aforementioned Tax Ordinances were submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Sections 458 and 57 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" (LGC), in order to find out whether the subject Ordinances approved by the concerned Sangguniang Barangay are within the scope of its prescribed powers, and also whether the same are not inconsistent with law or city ordinances;

WHEREAS, this Sanggunian, in the exercise of its review powers, and after thorough examination of the aforesaid Barangay Tax Ordinances, finds that the same were enacted for the purpose of raising revenues for the Barangay, which will in turn be utilized to deliver basic services and promote the general welfare and convenience of the Barangay constituents;

WHEREAS, this Sanggunian, after thorough examination, finds that the Tax Ordinances are not inconsistent with existing laws and city ordinances and were enacted within the scope and authority of the Barangay, and therefore, manifests herein no objections to its implementation, and even urges that they be implemented immediately in order to speedily further the noble ends they seek for welfare of the Barangay;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Esteban V. Laurente and Jasper C. Yerro; be it

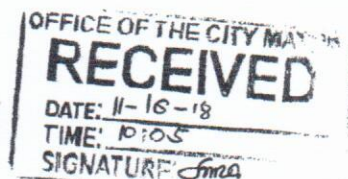

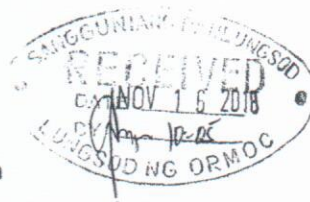

PREFATORY STATEMENT

Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the barangay, through an appropriate ordinance, may levy taxes, fees, and charges for any service rendered in the amount commensurate to such service provided, which shall exclusively accrue to the local government unit concerned: provided, that the ordinance levying such taxes, fees or charges shall not be enacted without any prior public hearing conducted for the purpose prior to the enactment thereof.

In 2015, the Sangguniang Barangay enacted Tax Ordinance No. 2015-004: An Ordinance Amending Some Provision in Accordance of Barangay Ordinance No. 2007-03 per Sangguniang Panlungsod Resolution 2007-101 Entitled "An Ordinance Prescribing the Rates on the Issuance of Barangay Clearances and Other Certificates, Permit and Other Charges." After careful review of said ordinance together with the Barangay's Annual Income and increase in current market prices, it was found by the Committee on Finance and Appropriations that the current rates of issuance of Barangay Clearances, Permits and other charges levied by the Barangay is no longer commensurate to meet the exigencies of delivering basic services to the community. Thus, an amendment on the prescribed rates on the issuance of Barangay Clearance, Permits and Other Certificates to raise and augment the Barangay's financial resources in order to respond to the increasing costs of various needs and to effectively carry out its mandate of providing for public services to its constituents was proposed.

Relative to this matter, during the Barangay Assembly held at the Brgy. Cogon Gym on October 28, 2018 that was attended by residents of Barangay Cogon, SB Member Antonio M. Codilla, Chairman of the Committee on Finance and Appropriations, presented to the public the proposition for the collection of fees. Gaining no objection from the public, an ordinance was promulgated to take effect on January 1, 2019.

BRGY. COGON TAX ORDINANCE NO. 2018-001

AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 2015-004 ENTITLED "AN ORDINANCE AMENDING SOME PROVISION IN ACCORDANCE OF BARANGAY ORDINANCE NO. 2007-03 PER SANGGUNIANG PANLUNGSOD RESOLUTION 2007-101 ENTITLED "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMIT AND OTHER CHARGES".

**BE IT ORDAINED**, by the Sangguniang Barangay of Cogon, Ormoc City, by virtue of the powers vested upon this council, pursuant to the provisions of RA 7160, otherwise known as the Local Government Code of 1991, more particularly by Sections 129, 152, 187 and paragraphs 1 and 2 of section 391 thereof that;

**Section 1** – As it has been found out by the Committee on Finance of this Sanggunian, that the rates on the issuance of the Barangay Clearances, Permits and other Charges levied by the Barangay Ordinance No. 2015-004 per Sangguniang Panlungsod Resolutions No. 2015-034 is no longer commensurate to the services it provides for our clientele that it has recommended to this Council an increase on such fees;

**Section 2** – Finding the recommendation both meritorious and urgent, this council hereby amends the provisions of Barangay Tax Ordinance No. 2015-004 per Sangguniang Panlungsod Reselution No. 2015-034.

**Section 3** – The above-mentioned fees shall be paid at the Barangay Treasurer at the same time the same shall be applied for;



PREFATORY STATEMENT

Under Local Government Code of 1991, Barangays are authorized to generate income and allowed to levy fees or charges for the services rendered in connection with the regulation for the barangay owned properties subject to the provisions herein, consistent with the basic policy of Local autonomy, such taxes, fees and other charges shall accrue exclusively to the Local Government Unit.

Relative to this matter, during Barangay Assembly on October 28, 2018 attended by the residents of Barangay Cogon, the proposed charges for the use of Barangay facilities was presented to the public by SB Member Antonio M. Codilla, Chairman of the Committee on Finance and Appropriation. Gaining no objection from the Public, an Ordinance was promulgated.

SECTION 2. Time of Payment. The fees imposed in SECTION 1 hereof, therefore, shall be paid upon application for reservation. However, the Sangguniang Barangay may, for a justifiable reason or cause, extend the time of payment of such fees without surcharge or penalties but only for a period not exceeding 15 days.

SECTION 3. Place of Payment. All fees and charges payable under the ordinance shall be paid to the Barangay Treasurer who shall immediately issue therewith the corresponding government prescribed official receipt showing, among other things, the nature of the fees and charges and the amount actually collected.

SECTION 4. Surcharge and Penalties on Unpaid Fees or Charges. If the fees or charges imposed are not paid on time in accordance with the provisions thereof, there shall be a charge of twenty percent (20%) of the amount of the fees or charges due, and interest at the rate of two percent (2%) per month of the unpaid fees, or charges including surcharges, until such amount is fully paid, but in no case shall the total interest on the unpaid amount or portion thereof exceed twelve (12) months.

SECTION 5. Repealing Clause. All ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended, or modified accordingly.

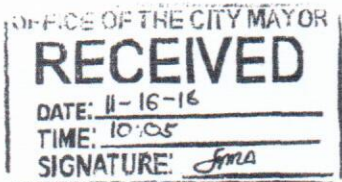
SECTION 6. Effectivity. This ordinance shall take effect upon the affirmative action of the Sangguniang Panlungsod Lungsod of Ormoc City in the exercise of its review powers.
