**A RESOLUTION CONFIRMING MR. TROY BUMAGAT AND
MR. ANTHONY HERRERA AS PRIVATE SECTOR
REPRESENTATIVES AND ESTRELLA MARIA S.
PANGILINAN AS THE NGO REPRESENTATIVE TO THE
ORMOC CITY INVESTMENT INCENTIVES BOARD.**

WHEREAS, Ordinance No. 026 series 2016 also known as the Revised Ormoc City Investment Incentives Code of 2016 provides under Section 7 thereof that the Board shall be composed as follows:

x x x x

- f. Two (2) Private Sector Representatives from the following major Investment Priority Areas, namely: 1) energy; 2) processing or manufacturing; 3) agricultural crop industry; 4) agricultural livestock, poultry and fisheries industry; and 5) academic institutions, with both representatives not belonging to a single area to be appointed by the City Mayor for a term of two (2) years, and duly confirmed by the Sanggunian;
- g. A representative of a Non-Government Organization (NGO) duly accredited by the Sanggunian, to be appointed by the City Mayor for a term of two (2) years, and duly confirmed by the Sanggunian x x x;

WHEREAS, the Ormoc City Investment Incentives Board is created to implement the provisions of the Ormoc City Investment Incentives Code and to supervise and manage the operation of the Local Economic and Investment Promotions Center;

WHEREAS, the appointment of Mr. Troy Bumagat and Mr. Anthony Herrera as Private Sector Representatives and Maria Estrella S. Pangilinan as NGO Representative have been submitted to the Sangguniang Panlungsod for confirmation on January 10, 2019 and was referred to the Committee on Good Government on January 17, 2019;

WHEREAS, upon close scrutiny by this Sanggunian, the said request for confirmation on some members of the Ormoc City Investment Incentives Board is evidently found to be consistent and in accordance with the pertinent ordinances particularly Ordinance No. 026 series of 2016 and further, to be beneficial to this city in light of the Ormoc City Investment Incentives Board's vital role in the grant of investment incentives with the aim of convincing more investors to pour their investments in Ormoc City;

WHEREAS, after clearly finding said request of the Honorable City Mayor to be in order and bequeathed with merit and favor, this Sanggunian, hence, lends its full support and favorable consideration to the same;
