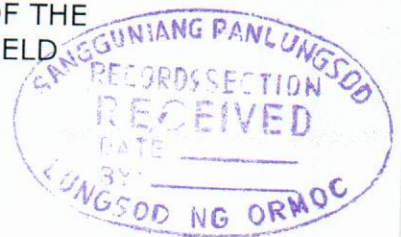

**RESOLUTION NO. 2019-027**

**A RESOLUTION EXPRESSING SUPPORT TO THE  
TRANSFER OF THE DATES OF THE 2019 EASTERN  
VISAYAS REGIONAL ATHLETIC ASSOCIATION  
(EVRAA) MEET IN ORMOC CITY FROM MARCH 3-8,  
2019 TO APRIL 07-12, 2019.**

WHEREAS, this august Body was in receipt an Indorsement from the Office of the City Mayor dated January 22, 2019 recommending the postponement of this year EVRAA meet from March 3-8, 2019 to March 24-29, 2019;

WHEREAS, Ormoc City was chosen as the host city for 2019 EASTERN VISAYAS REGIONAL ATHLETIC ASSOCIATION (EVRAA) by way of selection conducted by Department of Education Region VIII Office pursuant to its (DepEd) mandate provided for under Section 8 of Republic Act No. 10588;

WHEREAS, Office of the City Mayor issued an Executive Order No. 30, series of 2018 dated July 24, 2018 creating the EVRAA Coordinating Committee 2019 which the Body is tasked to prepare consolidated plan of events for the EVRAA, create needed technical committees/ working groups involving other interested parties, and oversee and monitor the implementation of plans and programs of the 2019 EVRAA;

WHEREAS, in a letter attached to the said Indorsement dated January 19, 2019, Mayor Richard I. Gomez cited the reasons why the postponement should be granted due to the fact that the City had undertaken repairs/renovation(s) on existing facilities such as track and field oval renovation, grandstand construction and elevated basketball court construction, improvement of billeting quarter facilities and efficient water supply system to ensure quality accommodation for all the contingents of the said event;



WHEREAS, Mayor Gomez also stressed that the delays of the above-stated facilities were brought about by frequent days of continuous heavy rains during the rainy season;

WHEREAS, the aforesaid letter was received by DepEd Region VIII Office on January 21, 2019;

WHEREAS, this august Body sees the wisdom and practicality in the postponement of the EVRAA to a later date to ensure the city, security, comfort and convenience to the participant to the meet;

WHEREAS, further, this Body supports and joins the call of Mayor Richard I. Gomez to move the EVRAA to a later date to enable the city to complete its preparation in a manner that is more than sufficient to receive thousands of dignitaries, athletes and visitors to the one (1) week event;

WHEREAS, finally, this Body finds that the subject recommendation by the City Mayor for the moving of the dates of the conduct of the EVRAA 2019 meet is meritorious and rests on practical and justifiable grounds as it is intended for the successful holding of the same, and therefore, is most deserving of this Sanggunian's prompt and full support;

WHEREFORE, on motion of SP Member Jasper C. Yerro, Chairman, Committee on Youth and Sports Development, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Gregorio G. Yrastorza III and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION EXPRESSING SUPPORT TO THE TRANSFER OF THE DATES OF THE 2019 EASTERN VISAYAS REGIONAL ATHLETIC ASSOCIATION (EVRAA) MEET IN ORMOC CITY FROM MARCH 3-8, 2019 TO APRIL 07-12, 2019;
