A RESOLUTION AMENDING SECTION 1, RULE VIII OF RESOLUTION NO. 2016-001, **ENTITLED:** RESULVIZON ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 14TH SANGGUNIANG PANLUNGSOD NG ORMOC", AS AMENDED.

" RULE VIII - REGULAR AND SPECIAL SESSIONS AND PRE-SESSION CAUCUS

SECTION 1. The regular session of this Sanggunian shall be "once a week" to be held at the Sanggunian Session Hall every Monday at exactly 1:30 o'clock in the afternoon."
