**RESOLUTION NO. 2019-049**

**A RESOLUTION GRANTING THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR THE AUTHORITY TO ACCEPT AND SIGN A DEED OF DONATION BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), AS DONEE, AND ROOSEVELT CHEMICAL INC. (RCI), AS DONOR, RELATIVE TO THE REPAINTING OF ROAD SIGNAGES AND OTHER RELATED SIGNAGES BY THE LATTER IN FAVOR OF THE FORMER FOR A PERIOD OF FIVE (5) YEARS.**

WHEREAS, the Sangguniang Panlungsod was in receipt of an Endorsement Letter dated February 12, 2019 requesting for the issuance of a Resolution granting the City Mayor or his representative the authority to enter into and sign the a Deed of Donation to be entered into by and between the Roosevelt Chemical Inc. (RCI) and the Local Government Unit of Ormoc (LGU-Ormoc), re: repainting of road signs and related signages for the latter for a period of five (5) years;

WHEREAS, RCI by its act of liberality and generosity, voluntarily and freely gives and conveys, by way of donation, its services consisting of providing free of charge paint and allied products necessary for the repainting and/or installation of road signages in Ormoc City for a period of five (5) years;

WHEREAS, the City Legal Officer, Atty. Josephine A. Mejia-Romero, has expressed an opinion dated February 4, 2019 recommending the approval of the aforementioned Deed of Donation (DOD) after finding that the draft of the DOD does not have anything legally objectionable to the basis, substance and purposes thereof, and that the same is likewise found to be not contrary to law, morals, good customs, public policy and public order;



WHEREAS, the subject DOD clearly and plainly provides the terms and conditions of the agreement of the parties thereto;

WHEREFORE, after a thorough examination of the aforementioned request by the City Mayor, this Sanggunian finds that the continuation of the herein subject is deemed noble, and that the same should be entered into for the best interests of the City and her constituents, and therefore deserving this august Body's full support, endorsement and prompt affirmative consideration to the same;

NOW, THEREFORE, on joint motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, jointly seconded by SP Members Tomas R. Serafica and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR THE AUTHORITY TO ACCEPT AND SIGN A DEED OF DONATION BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), AS DONEE, AND ROOSEVELT CHEMICAL INC. (RCI), AS DONOR, RELATIVE TO THE REPAINTING OF ROAD SIGNAGES AND OTHER RELATED SIGNAGES BY THE LATTER IN FAVOR OF THE FORMER FOR A PERIOD OF FIVE (5) YEARS;

In like manner, the DONOR RCI offers to install road signages free of charge to the DONEE ORMOC LGU with only the same condition;

WHEREAS, the donation herein offered is proposed to continue for a period of FIVE (5) YEARS reckoned from the time of acceptance of this donation unless sooner discontinued upon proper notice;




