WHEREAS, pursuant to Executive Order No. 2, dated January 9, 2019, Hon. Josephine M. Ceniza was appointed as member of the Local Investment Incentives Board representing the City Development Council;

WHEREAS, Ordinance No. 026 series 2016 also known as the Revised Ormoc City Investment Incentives Code of 2016 provides under Section 7 thereof that the Ormoc City Investment Incentives Board shall be composed of:

(h) A member of the City Development Council chosen by the CDC for a term of two years, and duly confirmed by the Sanggunian;

WHEREAS, following the City Development Council (CDC) Resolution No. 3 series of 2019, the CDC endorses Hon. Josephine Ceniza as the representative of the City Development Council to the Ormoc City Investment Incentives Board;

WHEREAS, the Ormoc City Investment Incentives Board is created to implement the provisions of the Ormoc City Investment Incentives Code and to supervise and manage the operation of the Local Economic and Investment Promotions Center;



WHEREAS, the CDC Resolution endorsing Hon. Josephine Ceniza as CDC Representative was received by the Sangguniang Panlungsod for confirmation on March 18, 2019 and was referred to the Committee on Trade, Commerce, Industry, Employment & Livelihood on March 18, 2019;

WHEREAS, upon close scrutiny by this Sanggunian, the said request for confirmation of PB Josephine Ceniza as member of the Ormoc City Investment Incentives Board is found to be consistent with and in accordance with the pertinent ordinances particularly Ordinance No. 026 series of 2016 and further, to be beneficial to this city in light of the Ormoc City Investment Incentives Board's vital role in the grant of investment incentives with the aim of convincing more investors to pour their investments in Ormoc City;
