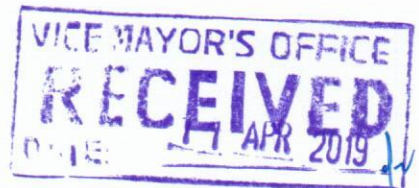

**RESOLUTION NO. 2019-082**

**A RESOLUTION CONFIRMING THE CREATION AND FULL  
COMPOSITION OF THE CITY DEVELOPMENT COUNCIL  
SECTORAL COMMITTEES.**

WHEREAS, this Sanggunian was in receipt of the City Development Council (CDC) Resolution No. 2 series of 2019 requesting the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc for adoption of the full composition of the City Development Council Sectoral Committees and the same was referred to the Committee on Good Government and Oversight on March 18, 2019, a copy of the said CDC Resolution and the composition of the CDC Sectoral Committees are hereto attached forming an integral part of this resolution.

WHEREAS, Republic Act 7160 also known as the Local Government Code of 1991 provides under Section 109 thereof that Local Development Councils shall exercise the following functions:

x x x x

1. Formulate long-term, medium-term, and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or competent authority.

WHEREAS, Republic Act 7160 provides under Section 112 thereof that the Local Development Councils may form sectoral or functional committees to assist the said Council in carrying out its mandate.

WHEREAS, the CDC Resolution No. 2 series of 2019 stated that the City Development Council shall be composed of five (4) sectoral committees to wit:

1. Economic Development Committee
2. Social Development Committee
3. Infrastructure and Utilities Development Committee
4. Development Administration Committee

WHEREAS, the CDC Sectoral Committees shall perform a supportive function to the CDC and review and evaluate matters pertaining to their respective sectors and shall carry out the following responsibilities:

- A. Integrate sectoral plans and programs of the local government units and coordinate all sectoral planning and programming activities of the sector;
- B. Review and endorse programs/projects of the local government units requiring CDC support;
- C. Integrate sectoral information and statistics in preparation of the annual development report;
- D. Assist the council in the translation of local development goals and policies into specific sectoral objectives;
- E. Facilitate and coordinate project preparation, implementation and monitoring within the sector; and
- F. Perform other functions as may be assigned by the council proper, or upon instruction of the Execom Chairman

WHEREAS, upon close scrutiny by this Sanggunian, the said request for confirmation on the creation and full composition of the CDC Sectoral Committees is evidently found to be consistent and in accordance with the pertinent laws particularly Republic Act 7160 and further, to be beneficial to this city in light of the CDC's vital role in improving the quality of life for the citizens of Ormoc City through the effective development and monitoring of the programs, projects and activities;

WHEREAS, after clearly finding said request of the Honorable City Mayor to be in order and bequeathed with merit and favor, this Sanggunian, hence, lends its full support and favorable consideration to the same;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee on Good Government and Oversight, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION CONFIRMING THE CREATION AND FULL COMPOSITION OF THE CITY DEVELOPMENT COUNCIL SECTORAL COMMITTEES;

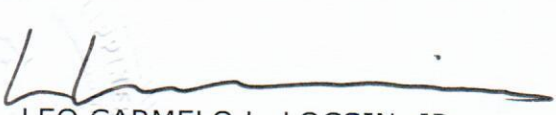

**A RESOLUTION CONFIRMING THE CREATION AND FULL COMPOSITION OF THE CITY DEVELOPMENT COUNCIL (CDC) SECTORAL COMMITTEES AND REQUESTING THE HONORABLE SANGGUNIAN PANLUNGSOD FOR THE ADOPTION OF THE SAME.**

WHEREAS, the list of the Full Composition of the CDC Sectoral Committee is herein attached;

WHEREAS, under Section 112 of RA 7160 provides the legal basis of the City Development Council (CDC) to form sectoral or functional committees to handle Social, Economic, Infrastructure, and Development Administration concerns whose composition is determined by the council;

WHEREAS, the membership in the Sectoral Committees shall be composed from among the CDC Full Council Members and from National Government Agencies (NGAs), Local Government Offices, Private Organizations (POs) and Accredited Non-government Organizations (NGOs) relevant to the Sector;

WHEREAS, there shall be four (4) sectoral committees in the CDC, Namely:

1. Economic Development Committee
2. Social Development Committee
3. Infrastructure and Utilities Development Committee
4. Development Administration Committee

WHEREAS, the functions of the Sectoral Committee shall include the following:

1. Perform a supportive function to the City Development Council
2. Review and evaluate matters pertaining to their respective sectors and endorse the same to the CDC Execom or to the CDC full council

WHEREAS, the Chairman of the Sectoral Committee shall be elected from among the members of the Committee;

WHEREFORE, on motion of Ms. Jean Justimbasti of Pagtinabangay Foundation Inc. (PFI) and duly seconded by Mr. Roque L. Villaneza, Jr. of Sustainable Organic Farmers Association in Ormoc City (SOFAOC), be it;

RESOLVED AS IT IS HERBY RESOLVED, to pass a Resolution confirming the creation and full composition of the City Development Council (CDC) sectoral committees and requesting the Honorable Sangguniang Panlungsod for the adoption of the same;

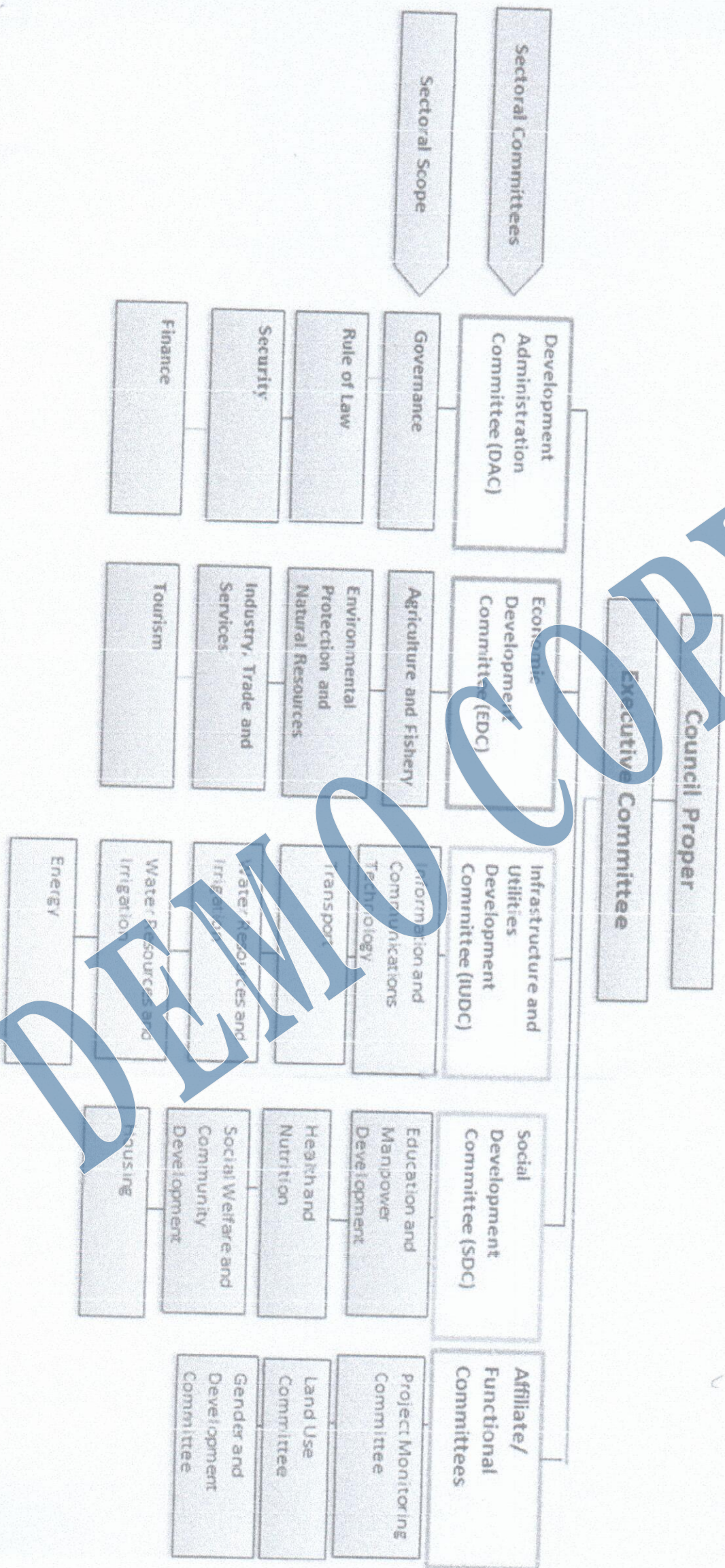
