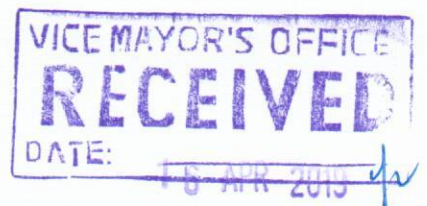

**RESOLUTION NO. 2019-086**

**A RESOLUTION ESTABLISHING THE SALVACION AGRO-INDUSTRIAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY AND ENDORSING THE LOCAL SCHOOL BOARD RESOLUTION NO. 2019-02 TO DEPED REGIONAL OFFICE FOR APPROPRIATE ACTION.**

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated March 25, 2019, requesting therein for appropriate action the LSB Resolution No. 2019-02 entitled: "A RESOLUTION ENDORSING TO THE SANGGUNIANG PANLUNGSOD NG ORMOC THE ESTABLISHMENT OF SALVACION AGRO-INDUSTRIAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY", a copy of the said resolution is hereto attached and made an integral part hereof;

WHEREAS, the City Government is grateful to Ms. Salvacion Ayuyao-Pennya for her gratuitous act of donating 4.1726 hectares with a condition that such donated property be used for a high school in Barangay Salvacion, Ormoc City;

WHEREAS, the request for the establishment of the said high school is also consonant to the thrust of DepEd Division Office to decongest New Ormoc City National High School (NOCNHS) that is currently suffering from heavy congestion and overcrowding of students;

WHEREAS, the Agro-Industrial High School seeks to provide specialized training and skills development in developing the potentials of Ormoc City as an agro-industrial city considering that more than half of its land is still considered agricultural in classification and in actual use;



WHEREAS, one of the requirements for the grant of recognition and approval for the establishment of the above mentioned school is a resolution from the Sangguniang Panlungsod;

WHEREAS, the City Government of Ormoc and the DepEd Division Office of Ormoc City held the same opinion that the establishment of the above-mentioned high school will encourage students to continue their education and ensure access of communities to secondary education and therefore lower the number of out-of-school youth;

WHEREAS, the opening of the said high school in Barangay Salvacion will also serve the need of neighboring barangays such as Nasunogan, Airport, Dayhagan, Sto Nino, and San Pablo;

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it will decongest the overcrowded New Ormoc City National High School and encourage the young population in Barangay Salvacion and surrounding communities to continue with their studies so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee, on Education and Manpower Development, severally seconded by SP Members Tomas R. Serafica, Esteban V. Laurente and Gregorio G. Yrastorza III; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION ESTABLISHING THE SALVACION AGRO-INDUSTRIAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY AND ENDORSING THE LOCAL SCHOOL BOARD RESOLUTION NO. 2019-02 TO DEPED REGIONAL OFFICE FOR APPROPRIATE ACTION;

ADOPTED, April 15, 2019.

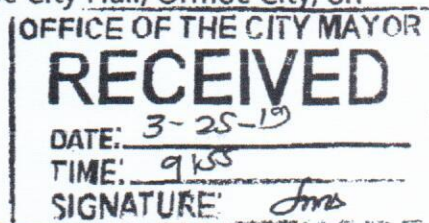




