# A RESOLUTION RENAMING ORMOC CITY SPORTS SENIOR HIGH SCHOOL TO ORMOC CITY REGIONAL SPORTS ACADEMY.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated March 25, 2019, endorsing the Local School Board Resolution No. 2019-03 entitled: "A RESOLUTION ENDORSING TO THE 14<sup>TH</sup> SANGGUNIANG PANLUNGSOD NG ORMOC THE REQUEST OF THE DEPARTMENT OF EDUCATION - ORMOC CITY DIVISION TO RENAME ORMOC CITY SPORTS SENIOR HIGH SCHOOL TO ORMOC CITY REGIONAL SPORTS ACADEMY", a copy of the said resolution is hereto attached and made an integral part hereof;

WHEREAS, pursuant to Section VI.A.5 of DepEd Order No. 40, s. 2014, the Local Sanggunian, under Section 99 (d) of the Local Government Code of 1991 is authorized to change the name of schools upon the recommendation of the Local School Board;

WHEREAS, Section 13 (b) of the Local Government Code of 1991 also provided that independent component cities may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:  $x \times x \times (3)$  Public elementary, secondary, and vocational or technical schools, community colleges and non-chartered colleges  $x \times x$ ;

WHEREAS, the special program for sports offered in the Ormoc City Sports Senior High School is advantageous as it will provide skills to the senior high school students on organizing sports events, tournament management and sports coaching which will also boost the chances of Eastern Visayas in sports competitions and that creating the Regional Sports Academy will help promote quality sports program not just for Ormoc City but the entire region of Eastern Visayas;

WHEREAS, pursuant to the guidelines of the National Historical Commission of the Philippines (NHCP) in changing names of schools, the passage of this Sanggunian resolution is necessary and a compliance to the requirements for approval of the NHCP on renaming of schools;

WHEREAS, upon close and thorough review, this Sanggunian finds that the request to change the name of the aforementioned school is not contrary to law, public policy, and public morals and that said change of name is beneficial to the City of Ormoc in achieving its goal of an outstanding sports program and therefore most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee, on Education and Manpower Development, jointly seconded by SP Members Tomas R. Serafica and Esteban V. Laurente; be it -

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION RENAMING ORMOC CITY SPORTS SENIOR HIGH SCHOOL TO ORMOC CITY REGIONAL SPORTS ACADEMY;
