RESOLUTION NO. 2019-088

**A RESOLUTION SUPPORTING THE REQUEST OF THE
DEPARTMENT OF EDUCATION (DEPED) ORMOC CITY
DIVISION TO OPEN A HIGH SCHOOL IN BARANGAY
SAN ANTONIO, ORMOC CITY AND TO CHANGE THE
NAME OF SAN ANTONIO ELEMENTARY SCHOOL INTO
SAN ANTONIO INTEGRATED SCHOOL.**

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated March 25, 2019, requesting therein for appropriate action the Local School Board (LSB) Resolution No. 2019-04 entitled: "A RESOLUTION ENDORSING TO THE 14TH SANGGUNIANG PANLUNGSOD NG ORMOC THE REQUEST OF THE DEPARTMENT OF EDUCATION (DEPED) ORMOC CITY DIVISION TO OPEN A HIGH SCHOOL IN BARANGAY SAN ANTONIO, ORMOC CITY AND TO MAKE SAN ANTONIO ELEMENTARY SCHOOL INTO SAN ANTONIO INTEGRATED SCHOOL";

WHEREAS, San Antonio Elementary School in Barangay San Antonio, Ormoc City and its neighboring barangays such as Mahayahay, Mabini, Quezon Jr, Danhug and Macabug produce a good number of elementary graduates sufficient enough to open Grade VII;

WHEREAS, the proposed opening of a new high school in Barangay San Antonio aims to bring the educational system close to the communities and ensure easier access to high school especially among the poor families where drop outs are observed;

WHEREAS, the request to open a new high school in Barangay San Antonio is also consonant to the thrust of DepEd Division Office to decongest big high schools such as Ipil National High School and that the new high school will be integrated in the elementary school in Barangay San Antonio and will offer complete elementary education and junior high school education;

WHEREAS, pursuant to Section VI.A.5 of DepEd Order No. 40, s. 2014, the Local Sanggunian, under Section 99 (d) of the Local Government Code of 1991 is authorized to change the name of schools upon the recommendation of the Local School Board;

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it will decongest bigger schools and encourage the students in uphill communities to continue with their studies so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee, on Education and Manpower Development, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III and Esteban V. Laurente; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION SUPPORTING THE REQUEST OF THE DEPARTMENT OF EDUCATION (DEPED) ORMOC CITY DIVISION TO OPEN A HIGH SCHOOL IN BARANGAY SAN ANTONIO, ORMOC CITY AND TO CHANGE THE NAME OF SAN ANTONIO ELEMENTARY SCHOOL INTO SAN ANTONIO INTEGRATED SCHOOL;
