**RESOLUTION NO. 2019-102**

**A RESOLUTION APPROVING AND GRANTING AUTHORITY  
TO THE CITY LOCAL CIVIL REGISTRAR TO PURCHASE  
ONE (1) UNIT OF BRAND NEW SERVICE VEHICLE IN  
THE AMOUNT OF ONE MILLION FOUR HUNDRED  
THOUSAND PHILIPPINE PESOS (PHP1,400,000.00).**

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated April 15, 2019 respectfully endorsing the request of Mr. Archilles A. Silva, City Civil Registrar, for the passage of a Resolution granting authority to purchase one (1) unit of Service Vehicle in the amount of ONE MILLION FOUR HUNDRED PHILIPPINE PESOS (PHP1,400,000.00);

WHEREAS, the requested vehicle shall be used by the City Local Civil Registrar as a replacement of one of the current service vehicle (Mitsubishi Adventure GLK 2.0L M) of the same office which has been purchased and in use for almost seventeen (17) years, and, by reason of age, is already dilapidated and no longer road worthy;

WHEREAS, the requested vehicle shall be used by the same office to provide uninterrupted services and assistance to the public and for the use of the same office for registration activities within the city and other areas within Leyte, for report submissions to the Philippine Statistics Office in Tacloban, and for other office related travel activities;



WHEREAS, the City Accountant, City Budget Officer, and the City Treasurer issued a Certificate of Availability of Funds dated March 19, 2019 stating therein that the City Local Civil Registrar has available funds for the purchase of the aforementioned vehicle in the amount of ONE MILLION FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,400,000.00) to be sourced from the CY 2016 General Fund (Unexpended Capital Outlay for Motor Vehicle), a copy of said certification is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate and improve the effectiveness and efficiency of the requesting office which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;

WHEREFORE, on motion by SP Member Mario M. Rodriguez, Chairman of the Committee on Finance and Appropriation, duly seconded by Tomas R. Serafica; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION APPROVING AND GRANTING AUTHORITY TO THE CITY LOCAL CIVIL REGISTRAR TO PURCHASE ONE (1) UNIT OF BRAND NEW SERVICE VEHICLE IN THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,400,000.00);
