RESOLUTION NO. 2019-103

**A RESOLUTION CONGRATULATING THE DEPARTMENT OF
EDUCATION (DEPED) ORMOC CITY DIVISION FOR WINNING
THE OVER-ALL CHAMPIONSHIP OF THE 2019 EASTERN
VISAYAS REGIONAL ATHLETIC ASSOCIATION (EVRAA) MEET
HELD IN ORMOC CITY FROM APRIL 7-12, 2019; AND FURTHER
COMMENDING THE CITY GOVERNMENT OF ORMOC FOR THE
PEACEFUL AND SUCCESSFUL HOSTING OF THE SAID EVRAA
MEET.**

WHEREAS, Sec. 19 (1), Article XIV of the 1987 Philippine Constitution provides that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, Sec. 8 of Republic Act 10588, otherwise known as the Palarong Pambansa Act of 2013, mandates the Department of Education (DepEd) Regional Offices to organize Regional Athletics Associations (RAAs) which shall supervise the conduct of the regional meets and organize their respective regional delegations to the Palarong Pambansa;

WHEREAS, by virtue of Sec. 11 of the Implementing Rules and Regulations of RA 10588, the Eastern Visayas Regional Athletic Association (EVRAA) Meet was organized, and pursuant to the same, the DepEd Regional and Division Offices are mandated to coordinate with Local Government Units (LGUs) to provide support services in the local meets and the like;

WHEREAS, to recall, the DepEd Ormoc City Division delegation was the overall champion in the 2018 EVRAA Meet held from February 4-10, 2018 in Calbayog City, Samar;

WHEREAS, in this year's EVRAA Meet, held from April 7-12, 2019 in this City, the DepEd Ormoc City Division delegation emerged triumphant as the overall champion, and was not only able to defend its title but also earned a total of three hundred twenty-eight (328) medals, one hundred sixty-two (162) gold, ninety-seven (97) silver, and sixty-nine (69) bronze medals; eighty-nine (89) more medals compared to the previous year;

WHEREAS, the two (2) consecutive overall championship in the EVRAA Meet is a first in the history of the DepEd Ormoc City Division delegation deserving of a high commendation and recognition of all the personal sacrifices, determination and discipline displayed by the athletes, trainers, and coaches in carrying the name of Ormoc to glory;

WHEREAS, said victorious outcome and feat is the result of the steady and unending support and thrust of the City Government of Ormoc, under the leadership of the City Mayor Richard I. Gomez, in mobilizing people in the grassroots to participate in various sports program, and in developing and honing the athletic skills and talents of the Ormocanons by providing them with highly-qualified trainers and coaches, through the provision of high quality sports equipment, and by developing and investing in various world-class sports infrastructure and facilities; all for the benefit of the youth and Ormocanons in general;

WHEREAS, this august Body deems it fitting that the DepEd Ormoc City Division and delegates be profoundly commended and recognized for their effort, hardwork, determination and discipline in winning as the over-all champion of the 2019 EVRAA Meet and for bringing pride and glory to the City of Ormoc;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it
