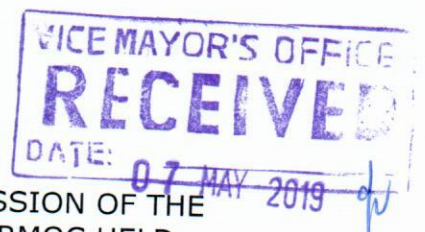

**RESOLUTION NO. 2019-104**

**A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF TOPCA INC. FOR THE ESTABLISHMENT AND OPERATION OF BINGO GAMES, BOTH TRADITIONAL AND ELECTRONIC BINGO, LOCATED AT 3<sup>RD</sup> LEVEL, ROBINSONS PLACE, BARANGAY COGON, ORMOC CITY, PROVIDED IT CONFORMS TO THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) AND GAMING SITE REGULATIONS.**

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated March 18, 2019, endorsing to the Sangguniang Panlungsod for its appropriate action and consideration, the request of TOPCA Inc. for a letter of no objection as an initial requirement per PAGCOR Gaming Site Regulatory Manual;

WHEREAS, the PAGCOR Charter PD 1869 as amended by RA 9487 requires any site for PAGCOR operations to obtain the consent of the local government unit having territorial jurisdiction over the chosen site through a Letter of No Objection (LONO) as an initial requirement by PAGCOR Gaming Licensing and Development Department and prior to PAGCOR's issuance of a Grant of Authority;

WHEREAS, the said applicant has properly secured the Resolution Interposing No Objection to operate a "Traditional and Electronic Bingo" in the City particularly in the 3<sup>rd</sup> level, Robinsons Place, Barangay Cogon, Ormoc City, from the Sangguniang Barangay of Barangay Cogon, Ormoc City through Resolution No. 06 s 2019, a copy of the resolution is hereto attached as Annex "A" and form integral part of this resolution;



WHEREAS, the said applicant has properly secured the letter/certification Interposing No Objection to operate a "Traditional and Electronic Bingo" in the City particularly in the 3<sup>rd</sup> level, Robinsons Place, Barangay Cogon, Ormoc City, from the Our Lady of Fatima Parish located in Cogon, Ormoc City, copy of the letter/certification is hereto attached as Annex "B" and form integral part of this resolution;

WHEREAS, the City Legal Officer has reviewed the request of TOPCA Inc., for a gaming license to operate in Robinsons Place, Ormoc City and expressed no opposition to the application but commented that the proposed gaming site should be compliant with the LGU requirements and regulations on the establishment and conduct of gaming corporations and that the grant of license of the proposed gaming site is subject to the approval of the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, strict control over the admission of persons under 21 years of age shall be administered in the gaming area as stated in Presidential Decree No. 1869 otherwise known as "consolidating and amending Presidential Decree Nos. 1067-A, 1067-B, 1067-C, 1399 and 1632, relative to the franchise and powers of the Philippine Amusement and Gaming Corporation (PAGCOR) under Title IV, Section 14, No. 2.c;"

WHEREAS, upon close and thorough review, this Sanggunian, finds the request for no objection in order and not contrary to existing laws, ordinances, rules and regulations thereby interposes no objection to the application of TOPCA, Inc. to operate and manage a Bingo gaming site in Ormoc City provided that the same is in accordance with the City's zoning ordinance and other ordinances set forth by the City of Ormoc to protect the general welfare of its constituents and subject to all existing laws, rules and regulations and in compliance sine qua non to the following conditions to wit:

- a. The proponent shall comply with all the requirements of the concerned national and local agencies and all other applicable and necessary provisions of existing laws, rules, ordinances and regulations relative to the operations of the proponent.
- b. The proponent shall provide priority in employment to qualified residents of Ormoc City;
- c. No expansion, alteration and improvement shall be made by the proponent in its location and operation without prior clearance from PAGCOR and this Sanggunian;
- d. The proponent shall be responsible and shall implement strict control over the admission of persons under 21 years of age shall be administered in the gaming area as stated in Presidential Decree No. 1869 otherwise known as "consolidating and amending Presidential Decree Nos. 1067-A, 1067-B, 1067-C, 1399 and 1632, relative to the franchise and powers of PAGCOR under Title IV, Section 14, No. 2.c;
- e. The proponent shall adhere to its commitment to conduct activities of corporate social responsibilities particularly to its host barangay;
- f. The Proponent shall comply to the rules and regulations of PAGCOR and shall always be subject to any ordinances that shall be enacted by the Sangguniang Panlungsod prescribing guidelines in regulating such establishments of its nature in the city of Ormoc;



- g. The proponent shall comply with the provisions set forth by the Anti-smoking Ordinance of Ormoc City;
- h. The proponent shall settle/pay all the required taxes, fees and charges required and/or to be imposed by the city government of Ormoc;
- i. The proponent shall at any time, even without prior notice, allow authorized city government officials and employees for the sole purpose of conducting an on-the-spot inspection and monitoring;
- j. Any misinterpretations, false statements or allegations relevant to the issuance of this decision/clearance shall be a sufficient cause for its revocation;
- k. The proponent shall be responsible for any activity that will endanger the general welfare, safety, and health of the not just residents of its host barangays but its clientele as well and in the event of such incident if proven valid shall cause for the revocation of the permit issued to the proponent and shall immediately cause the termination, cancellation and stoppage of its operation.

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee on Trade, Commerce, Industry, Employment and Livelihood, severally seconded by SP Members Tomas R. Serafica, Roiland H. Villasencio and Gregorio G. Yrastorza III; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF TOPCA INC. FOR THE ESTABLISHMENT AND OPERATION OF BINGO GAMES, BOTH TRADITIONAL AND ELECTRONIC BINGO, LOCATED AT 3<sup>RD</sup> LEVEL, ROBINSONS PLACE, BARANGAY COGON, ORMOC CITY, PROVIDED IT CONFORMS TO THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) AND GAMING SITE REGULATIONS;


