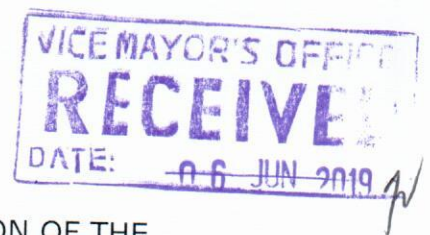

RESOLUTION NO. 2019-115

AN OMNIBUS RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO AND SIGN THE DEEDS OF DONATION (DODs) IN FAVOR OF LGU-ORMOC, AS DONEE, WITH RUFINO BRODETH AND CO., INCORPORATED, AND ORMOC MIDTOWN TENNIS CLUB, AS DONORS, RELATIVE TO THE DONATION OF VARIOUS MATERIALS FOR THE TENNIS COURT FACILITY LOCATED IN THE GOVERNMENT CENTER ALONG CORNERS DALINGDINGAN STREET AND C.S. MENDOLA STREET, THIS CITY.

WHEREAS, this august Body was in receipt of an Endorsement from the Office of the City Mayor dated May 22, 2019, requesting therein for the passage of a resolution granting the City Mayor the authority to enter into and sign the Deeds of Donation (DODs) in favor of LGU - ORMOC with Rufino Brodeth and Co., Incorporated, and Ormoc Midtown Tennis Club, as Donors, for the donation of various materials for the Tennis Court Facility and further classifying the same as URGENT, copies of the respective DODs are hereto attached as Annexes "A", "B", and "C" and made an integral part hereof;

WHEREAS, out of pure liberality and generosity, the Donors, RUFINO BRODETH AND CO., INCORPORATED, as represented by its President, MR. ROMMEL C. WHEREAS, the Donors, in their respective Deed of Donations provide that LGU-Ormoc, as DONEE, shall utilize and install all donated materials for the improvement of the City's Tennis Court Facility at the Government Center along corners Dalingdangan Street and C.S. Mendola Street, this City;
