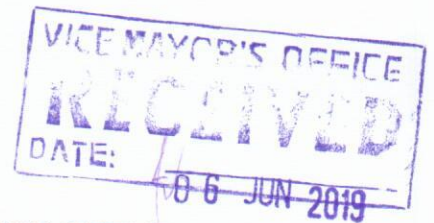

RESOLUTION NO. 2019-117

A RESOLUTION CONFIRMING THE AUTHORITY OF CITY MAYOR RICHARD I. GOMEZ, AND RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), AS DONOR, AND THE PHILIPPINE NATIONAL POLICE - ORMOC CITY POLICE OFFICE (PNP), AS DONEE, RELATIVE TO THE DONATION OF FIREARMS, AND THEREBY SUPPLEMENTING RESOLUTION NO. 2019-060 DATED MARCH 11, 2019.

WHEREAS, this august Body was in receipt of an Endorsement from the Office of the City Mayor dated May 21, 2019, requesting therein for the passage of a resolution for the ratification of the Deed of Donation between LGU-Ormoc and PNP;

WHEREAS, on March 11, 2019 the Sanggunian Panlungsod adopted Resolution No. 2019-060 entitled: "A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), TO SIGN THE DEED OF DONATION (DOD) EXECUTED BY AND BETWEEN LGU-ORMOC, AS DONOR, IN FAVOR OF THE PHILIPPINE NATIONAL POLICE (PNP), AS DONEE, RELATIVE TO THE DONATION OF FIREARMS" which authorized City Mayor Richard I. Gomez, for and on behalf of LGU-Ormoc to sign the Deed of Donation (DOD) executed by and between LGU-Ormoc in favor of the PNP relative to the donation of firearms;

WHEREAS, in the aforementioned resolution and Deed of Donation attached thereto, the subject of the said donation were only as follows:

WHEREAS, it has been found out that there are other equipment indicated in the original request and documents that were not included in the said Resolution and Deed of Donation;

WHEREAS, the additional equipment that LGU-Ormoc intends to donate to PNP are as follows:

- a. THREE HUNDRED SIXTY (360) pieces Magazines for GALIL ACE21N 5.56mm,
- b. THIRTY SIX (36) pieces Magazines for GALIL ACE 52 7.62mm,
- c. THREE (3) units Meprolight NVG Model: MINIMON MINI MONOCULAR GEN III,
- d. SIX (6) units Meprolight NV Binocular Model: BOXER GEN II;

WHEREAS, there has been a new Deed of Donation executed by LGU-Ormoc and PNP which covers all the items intended to be donated which is hereto attached as Annex "A" and this august Body finds that it is in accordance with law, and the provisions therein are in conformity with the intentions and goals of the previous Deed of Donation, which is to provide essential equipment to our Police in support of the Office's drive of crime prevention and the promotion of peace and order in the City;

WHEREFORE, after a thorough examination of the aforementioned request by the City Mayor, this Sanggunian finds that it is to the best interest of the City, and therefore deserving this august Body's full support, endorsement and prompt affirmative consideration to the same;

NOW, THEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, duly seconded by SP Member Vincent L. Rama; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION CONFIRMING THE AUTHORITY OF CITY MAYOR RICHARD I. GOMEZ, AND RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), AS DONOR, AND THE PHILIPPINE NATIONAL POLICE - ORMOC CITY POLICE OFFICE (PNP), AS DONEE, RELATIVE TO THE DONATION OF FIREARMS, AND THEREBY SUPPLEMENTING RESOLUTION NO. 2019-060 DATED MARCH 11, 2019.

ADOPTED, June 4, 2019.

RESOLVED FURTHER, that a copy of the final and notarized Deed of Donation be submitted to the Sangguniang Panlungsod for its information and files.

RESOLVED FINALLY, to furnish copies of this resolution each to the City Mayor of Ormoc Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the City Legal Officer, Atty. Josephine Mejia-Romero; the Philippine National Police - Ormoc City Police Office; the City Local Government Operations Officer, DILG; and all other offices concerned for their information and guidance.

DEED OF DONATION

KNOW ALL MEN BY THESE PRESENTS:

This DEED OF DONATION, made and executed by:

LOCAL GOVERNMENT UNIT OF ORMOC, a juridical entity existing in accordance with pertinent laws, represented herein by **RICHARD I. GOMEZ**, of legal age, Filipino and a resident of Ormoc City, hereinafter referred to as the "DONOR";

- IN FAVOR OF -

PHILIPPINE NATIONAL POLICE- ORMOC CITY POLICE OFFICE, a juridical entity existing in accordance with pertinent laws, represented herein by **PSSUPT. ARMEL S. GONGONA** of legal age, Filipino and a resident of Ormoc City, hereinafter referred to as the "DONEE";

WITNESSETH, that:

WHEREAS, the DONOR is the purchaser/ _____ of firearms listed and described as follows:

- a. THIRTY (30) units Galil Assault Rifle Model ACE21N, caliber 5.56mm NATO Made in Israel inclusive of 2 pieces magazines;
- b. THREE (3) units Galil Assault Rifle Model ACE 52 caliber 7.62 x 51mm Made in Israel inclusive of 2 pieces magazines.
- c. THREE HUNDRED SIXTY (360) pieces Magazines for GALIL ACE21N 5.56mm
- d. THIRTY SIX (36) pieces Magazines for GALIL ACE 52 7.62mm
- e. THREE (3) units Meprolight NVG Model: MINIMON MINI MONOCULAR GEN III
- f. SIX (6) units Meprolight NV Binocular Model: BOXER GEN II

WHEREAS, the DONOR recognizes and supports the noble task of the DONEE in promoting peace and order and ensuring the safety and security of the residents and people of Ormoc;

WHEREAS, the DONOR desires to assist the DONEE and give further impetus to the performance by the latter of its mandate which includes but is not limited to hostage crisis, hostage negotiations and counter- terrorism in the Ormoc City through its Special Weapons and Tactic (SWAT) Team;

NOW, THEREFORE, for and in consideration of the foregoing premises and due to the magnanimity of the DONOR, the latter hereby transfers and conveys unto the DONEE, by way of DONATION, the equipment as enumerated above, subject to the conditions that:

- a. The DONEE shall, at its own expense, maintain the donated equipment and exercise all measures to ensure that said equipment are in functioning condition at all times;
- b. Observe all legal provisions relative to the use, ownership and possession of firearms, and for such purpose shall register the said firearms with the proper agency(ies)/ department(s) and secure the required permit(s) or license(s) pursuant to applicable laws and issuances;
- c. Devote the use of the equipment only for and within the City of Ormoc;
- d. Free the DONOR from any and all liability that may arise from the use and possession of the said firearms whether by the DONEE's authorized personnel or otherwise;

In the event that the conditions of the donation, as contained herein, are not complied with by the DONEE within thirty (30) days after the latter's failure to comply with the same is brought to its attention, this donation shall be automatically revoked and rendered ineffective and the DONOR shall regain ownership over the playground equipment and shall have the right to recover possession of the same.

The DONEE hereby accepts the donation of the equipment as listed herein together with the conditions herein imposed, and hereby expresses its gratitude and appreciation for the support, kindness and liberality of the DONOR.
