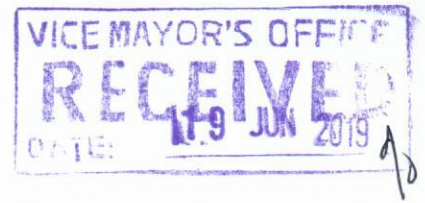

RESOLUTION NO. 2019-122

A RESOLUTION GRANTING AUTHORITY TO THE OIC-CITY TREASURER, MS. ALICIA C. DIMAPINGUN, TO OPEN A TRUST BANK ACCOUNT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES - ORMOC BRANCH (DBP-ORMOC) TO FACILITATE THE TRANSFER OF FUNDS FROM THE DEPARTMENT OF ENERGY (DOE) FOR THE DEVELOPMENT AND LIVELIHOOD FUND (DLF) PROJECT IN RELATION TO DOE ENERGY REGULATIONS NO. 1-94 (DOE-ER NO. 1-94) PROJECTS, UNDER THE TRUST FUND AND ACCOUNT NAME, TO WIT:

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter dated June 11, 2019 from the Office of the City Mayor respectfully requesting for the issuance of a resolution granting Ms. Alicia C. Dimapingun, OIC-City Treasurer, the authority to open a Trust Bank Account in one of our depository banks, the Development Bank of the Philippines (DBP), for the Development and Livelihood Project, in relation to DOE ER No. 1-94;

WHEREAS, Section 5 (i) of Republic Act No. 7638, otherwise known as the "Department of Energy Act of 1992" mandates the Department of Energy (DOE) to devise ways and means of giving direct benefits to the province, city, or municipality, especially the community and people affected, and equitable preferential benefit to the region that hosts the energy resource and/or the energy-generating-facility;

WHEREAS, the DOE promulgated Energy Regulations No. 1-94 (ER 1-94) on August 1, 1994 to operationalize the implementation of Section 5 (i) of Republic Act No. 7638, which regulation provides for the nature of benefits and scope of benefits the community and people affected, the pertinent host local government unit (LGU) shall be entitled to from the energy resource developer or power producer;

WHEREAS, the DOE issued Department Order (DO) Circular No. 2018-08-0021 entitled "*Providing for the Amendments to Rule 29 Part A of the Implementing Rules and Regulations of Republic Act No. 9138*", which took effect on August 23, 2018, to provide for the rules and guidelines for the effective administration, management, utilization and implementation of the financial benefits to the host communities;

WHEREAS, the DOE issued Department Order (DO) No. D02019-01-0001 entitled "Providing the Internal Guidelines and Procedures for the Transfer of Existing Funds in Relation to the Financial Benefits under Energy Regulations (E.R.) No. 1-94", which took effect on December 28, 2018, requiring Local Government Units (LGU) to submit to the DOE a Certification from any Authorized Government Depository Bank indicating therein the trust account for *Development and Livelihood Fund (DLF)* and *Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF)*;

WHEREAS, to recall, this Sanggunian passed Resolution No. 2019-070 on March 25, 2019 authorizing the OIC-City Treasurer to open a Special Bank Account with the DBP to facilitate fund transfers from the DOE in relation to ER No. 1-94, which bank account was opened specifically for the RWMHEEF Project;

WHEREAS, to fully comply with the requirements set forth by the DOE and to fully facilitate the transfer of funds for both projects, a new and separate account must be opened with our depository bank, the DBP, for the DLF project;

WHEREAS, on motion of SP Member Benjamin S. Pongos, Jr., Vice-Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Roiland H. Villasencio, Esteban V. Laurente and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE OIC-CITY TREASURER, MS. ALICIA C. DIMAPINGUN, TO OPEN A TRUST BANK ACCOUNT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES – ORMOC BRANCH (DBP-ORMOC) TO FACILITATE THE TRANSFER OF FUNDS FROM THE DEPARTMENT OF ENERGY (DOE) FOR THE DLF PROJECT IN RELATION TO DOE ENERGY REGULATIONS NO. 1-94 (DOE-ER NO. 1-94) PROJECTS, UNDER THE TRUST FUND AND ACCOUNT NAME, TO WIT:


