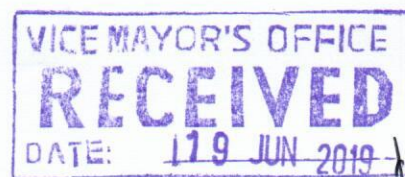

RESOLUTION NO. 2019-125

**A RESOLUTION APPROVING AND GRANTING AUTHORITY
FOR THE PURCHASE OF ONE (1) UNIT BRAND-NEW
SERVICE VEHICLE FOR THE USE OF THE CITY
SLAUGHTERHOUSE IN THE AMOUNT OF ONE MILLION
SIX HUNDRED THOUSAND PHILIPPINE PESOS
(PHP1,600,000.00).**

WHEREAS, the Sangguniang Panlungsod was in receipt of an endorsement letter from the Office of the City Mayor dated May 15, 2019 endorsing the request of Dr. Jose Arnil C. Corong, DVM, Veterinarian IV, for the passage of a resolution granting authority to purchase one (1) unit service vehicle in the amount of ONE MILLION SIX HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,600,000.00);

WHEREAS, the purchase of one (1) unit brand-new service vehicle will be used for operations of the slaughterhouse including, but not limited to, (1) hauling/carrying materials needed for its daily operation, and (2) for conveyance of documents and employees to and from the Ormoc City Hall and other city offices;

WHEREAS, the City Budget Officer, City Accountant and City Treasurer has issued a Certificate of Availability of Funds, dated April 4, 2019, stating therein that the required funds for the purpose is deemed available to be taken from General Fund - Capital Outlay for Motor Vehicles, specifically from CY 2019 Current appropriation and CY 2018 unexpended appropriation, said certificate is attached hereto as Annex "A" and made an integral part hereof;

WHEREAS, the Sanggunian finds that the request is deemed reasonable and meritorious considering the importance of the continued efficient and effective delivery of services of the City Slaughterhouse to the constituents of the City and to those from other cities and municipalities who avail of their services, and that it is not contrary to law, public policy and morals and therefore, is most deserving of this august body's full support;

WHEREFORE, on motion presented by SP Member Nolito M. Quilang, Member, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Esteban V. Laurente and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION APPROVING AND GRANTING AUTHORITY FOR THE PURCHASE OF ONE (1) UNIT BRAND-NEW SERVICE VEHICLE FOR THE USE OF THE CITY SLAUGHTERHOUSE IN THE AMOUNT OF ONE MILLION SIX HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,600,000.00);
