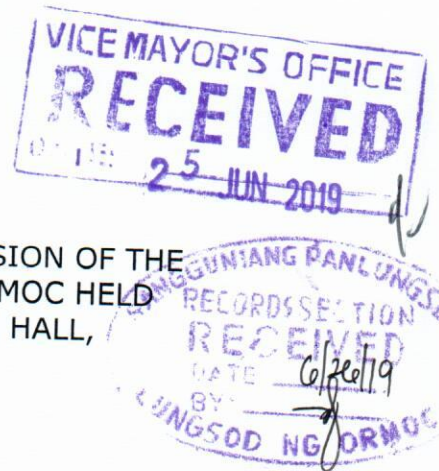

**RESOLUTION NO. 2019-126**

**A RESOLUTION AUTHORIZING THE CITY TREASURER TO  
CHARGE THE AMOUNT OF TEN THOUSAND FIVE  
HUNDRED TEN PHILIPPINE PESOS (PHP10,510.00)  
AGAINST THE CURRENT YEAR'S PERSONAL SERVICES  
APPROPRIATION OF THE OFFICE OF THE CITY MAYOR  
FOR THE PAYMENT OF 2018 MID-YEAR BONUS OF MS.  
ANALYN A. TAN.**

WHEREAS, this Sanggunian was in receipt of an endorsement letter from the Office of the City Mayor dated June 13, 2019, respectfully requesting for the issuance of a Resolution authorizing the release of the 2018 mid-year bonus of Ms. Analyn A. Tan, to be charged against the City Mayor's Office Salaries and Wages Casual/Contractual Lump Sum (1011-5-01-02-020), 2019 Appropriation (Current Appropriation);

WHEREAS, as stated in a letter from the Office of the City Treasurer dated May 27, 2019 and a Certification from the Human Resource Management Office dated May 30, 2019, Ms. Analyn A. Tan is entitled to receive the Mid-Year Bonus in the amount of TEN THOUSAND FIVE HUNDRED TEN PHILIPPINE PESOS (PHP10,510.00), and that her name was inadvertently not included in the list entitled to receive the Mid-Year Bonus for CY 2018;

WHEREAS, the City Budget Officer, the City Accountant, the OIC-City Treasurer, and the City Planning and Development Coordinator issued a Certification of Availability of Funds dated June 11, 2019 stating therein that the amount of TEN THOUSAND FIVE HUNDRED TEN PHILIPPINE PESOS (PHP10,510.00) is deemed available to be charged against Current Year's PS Appropriation of the Office of the City Mayor;



WHEREAS, this Sanggunian finds the request to be justified and reasonable as Ms. Analyn A. Tan is rightfully entitled to her 2018 Mid-Year Bonus, and not contrary to law, public policy and morals and therefore, is most deserving of this august body's full support;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Vice-Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, Rolando M. Villasencio and Esteban V. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF TEN THOUSAND FIVE HUNDRED TEN PHILIPPINE PESOS (PHP10,510.00) CHARGED AGAINST THE CURRENT YEAR'S PERSONAL SERVICES APPROPRIATION OF THE OFFICE OF THE CITY MAYOR FOR THE PAYMENT OF 2018 MID-YEAR BONUS OF ANALYN A. TAN;
