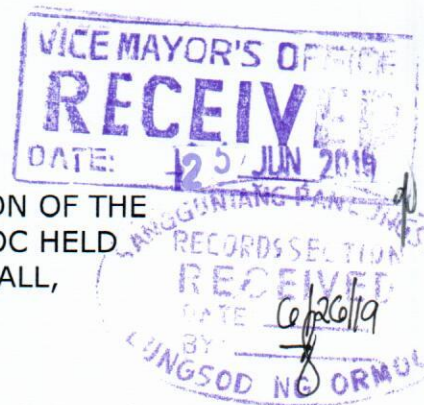

WHEREAS, SP Member Mario M. Rodriguez will be stepping down from government service as member of the 14th Sangguniang Panlungsod ng Ormoc at noontime of June 30, 2019;

WHEREAS, SP Member Rodriguez entry to the government service started when he ran as Sangguniang Panlungsod Member in May 2010 elections and got elected to the No.4 spot of the 12<sup>th</sup> Sangguniang Panlungsod membership from June 2010 to June 30, 2013. After serving said term, he went on to be elected again for two (2) more consecutive terms as a member of the august Body: from June 2013 to June 30, 2016 he garnered the same 4<sup>th</sup> spot of the 13<sup>th</sup> Sangguniang Panlungsod; and from June 2013 to June 30, 2019 he moved on to the 3<sup>rd</sup> spot of the present Sangguniang Panlungsod and at the same time acting as the Presiding Officer "Pro-Tempore";

WHEREAS, throughout his tenure he demonstrated great zeal, dedication and fairness in discharging his duties and responsibilities as Sanggunian Member while serving the Sanggunian thru various capacities: as a dedicated Chairman, Vice Chairman, and Member of several standing committees of the Sanggunian and as an author of a number of legislations that truly reflect the government's commitment to improve the local economy as well as to address the most basic and pressing concerns of the Ormocanon, most notably in the fields of health, education and finance which he focused on and advocated admirably and zealously during his tenure as a member of this august Body;
