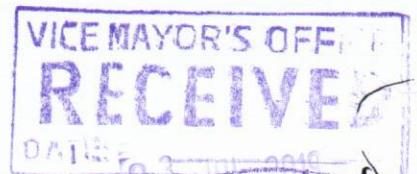

**RESOLUTION NO. 2019-003**

**A RESOLUTION COMMENDING THE GOOD PEOPLE OF  
ORMOC CITY FOR A PEACEFUL AND ORDERLY  
ELECTIONS AND FOR THE EXPRESSION OF THEIR  
POPULAR WILL DURING THE LOCAL AND NATIONAL  
ELECTIONS HELD ON MAY 13, 2019.**

WHEREAS, this May 13, 2019, the Ormocanons exercised their rights to suffrage, elected their chosen national and local officials and, consequently drew the path that the City of Ormoc will take in the next three (3) years;

WHEREAS, the May 13, 2019 National and Local Elections occurred in a generally peaceful and orderly manner;

WHEREAS, the high voter turnout in the City of Ormoc, at Eighty-three point Eighty-one percent (83.81%) of the total number of registered voters with little to no report of electoral violence in the City proves the active participation of the Ormocanons in the conduct of orderly, peaceful, credible and meaningful elections;

WHEREAS, regardless of their political affiliation and inclination, the acts of Ormocanons, both big and small, are great heroic initiatives for a continuing education for democracy;

WHEREAS, this august Body believes that such active participation is also an indication of mandate given by the Ormocanon electorate to the newly elected officials, both national and local;

WHEREFORE, on motion of SP Member Gregorio G. Yrastorza III, duly seconded by SP Member Eusebio Gerardo S. Penserga; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION COMMENDING THE GOOD PEOPLE OF ORMOC CITY FOR A PEACEFUL AND ORDERLY ELECTIONS AND FOR THE EXPRESSION OF THEIR POPULAR WILL DURING THE LOCAL AND NATIONAL ELECTIONS HELD ON MAY 13, 2019;
