RESOLUTION NO.187

Hon. Councilor Teleron moved, seconded by Hon. Councilor
Pajaron, that;

WHEREAS, the Superintendent of Schools for the Province
of Leyte has approved the establishment of intermediate classes
in the barrio of San Jose, Ormoc City;

WHEREAS, the present school site of barrio San Jose
Ormoc City is very inadequate for the purposes of the inter-
mediate classes to be opened thereat this current academic
year;

WHEREAS, communications from the Bureau of Education
authorities require that an additional of at least two(2) hec-
tares are needed to put the intermediate classes of barrio
San Jose, Ormoc City in proper operation in accordance with
the provisions of Section 558 of the Revised Teachers Manual
of the Bureau of Education;

WHEREAS, same communications state that failure on the
part of the authorities at Bo. San Jose, Ormoc City to provide
said additional site will perforce mean the closure of the
projected intermediate classes thereat this current academic
year, this, to the detriment of the educational needs of the
children thereat whose educational opportunities have been
retarded by the recent war;

WHEREAS, there are lots adjoining the present school
site of San Jose Elementary School which may be utilized for
its needs;

WHEREAS, the owners of said lots are unreasonably and
selfishly stubborn to cede said lots for the needs of the
intermediate classes of barrio San Jose, Ormoc City, thereby jeo-
pardizing public interest;

THEREFORE, BE IT RESOLVED, as it is hereby resolved, that
expropriation proceedings be instituted in order to acquire said
adjoining lots known as Lots Nos. 7030 and 8574 of Ormoc Cadastre
be be utilized as additional lots for the Elementary School site
of Barrio San Jose.
