RESOLUTION NO. 215

A RESOLUTION REQUESTING REPRESENTATIVE DOMINGO VELOSO TO
ALLOT A PORTION OF HIS PORK BARREL FOR ASPHALTING RIZAL, BONI-
FACIO AND SAN AGUSTIN STREETS AND REPAIR OF IPIL-BOROC ROAD.

WHEREAS, the Congress of the Philippines in its last
session has set aside millions of pesos for apportionment to
Congressmen as Pork Barrel in order to immediately use the
same in the construction and reconstruction of public works
in their respective districts, in the case of Representatives
and throughout the country in the case of Senators;

WHEREAS, many of the City Streets of Ormoc, were destroyed
by bombs and shells during the liberation period which, until
now, are still in bad shape due to lack of funds to repair and
maintain them;

WHEREAS, the Second District of Leyte of which Ormoc is
a part, is represented in our Congress by no less than the
Honorable Domingo Veloso, a man who has always at heart the
improvement and reconstruction not only of a portion of the
district he represents but also of the whole;

WHEREAS, time and again he has promised the people of
Ormoc that he will give to this City a big portion of his Pork
Barrel for 1948-1949;

NOW, THEREFORE, on motion of Honorable Councilor Parrilla,
seconded by Honorable Councilor Tugonon,

BE IT RESOLVED, as it is hereby resolved, to request the
Honorable Congressman Domingo Veloso a share in his Pork Barrel
for the following projects;

1. Repair and asphaltting Rizal Street.....P15,000.00
2. Repair and asphaltting Bonifacio Street..... 15,000.00
3. Repair and asphaltting San Agustin Street..... 10,000.00
4. Repair of Ipil-Borok Road..... 10,000.00

Total P 50,000.00

BE IT RESOLVED FURTHER, to send copies of this resolution
to Honorable Domingo Veloso, Honorable Jose Avelino, President
of the Senate and Senator Carlos S. Tan.
