Gentlemen:

With a view to improving the service of the Ormoc
Waterworks System and at the same time to prevent the extra-
vagant use or waste of water, I have the honor to request
authority to create a revolving fund in the amount of ₱2,000.00
with which to purchase as many watermeters as may be necessary.
The watermeters so purchased from this fund will either be
rented, at the rate fixed by that body, or sold at cost to
the consumers by installment subject to the approval of the
Department of Finance.
