Gentlemen:

This is to acknowledge receipt of your Resolution
No. 194 (s. 1948) requesting for the establishment of a
Branch Library in that City.

The proposition meets with the approval of this
bureau and that all aids (books, technical assistance,
printed forms, etc.) will be given, as provided for in our
regulations, as soon as all preparations are made for the
opening to the public of the branch.

This being a joint affair of the City and this
bureau, each has certain obligations to fulfill. The aids
mentioned above pertain to this bureau, while that City has
to provide, among others, the following:

(1) A building appropriate for library purposes, (2) at
least a long reading table with chairs, (3) necessary person-
nel and (4) bookshelves. For a complete understanding of the
matter a mimeographed copy of our requirements is enclosed
herewith.
