RESOLVED, as it is hereby resolved, to res-
pectfully request the Honorable, the Secretary of Finance,
to reconsider the creation of the positions of one addi-
tional dispensary attendant, three additional private
policemen, one market superintendent, one master sergeant,
one additional meat inspector, two additional clerks in
the municipal Board and one driver-mechanic, in view of
the fact that the services of the employees concerned
are essentially necessary in the interest of the public
service, that the services have been already paid up to
June 30, 1948, and that there was sufficient fund for the
purpose.

RESOLVED FURTHER, that copy of this resolution
be furnished the Honorable, the Secretary of Finance,
Manila for reconsideration as requested.
