RESOLUTION NO. 242

The City Fiscal of Ormoc City, Honorable Primo L. Cabrera, informed the Honorable City Councilors, that the owners or heirs of the land, Liborio Pardo, Condrada Pardo de Vensilao, Heirs of Fermin Pardo and Manuela Pardo, Lots Nos. 7030, with Certificate of Title No. 27978 and 8574, with Decree No. 713433, now in the office of the City Attorney, this City, situated in barrio San Jose, and which will be used for the additional school site of San Jose Elementary School, Ormoc City, will sign the Document of Sale in favor of the Government of Ormoc City, as soon as the price therefore, is fixed by the Appraisal Committee.

On motion of Honorable Councilor Parrilla, seconded by Honorable Councilor Evangelista,

RESOLVED, as it is hereby resolved, that the Appraisal Committee of Ormoc City, be requested to appraise the Two (2) hectares of land from Lots Nos. 7030 and 8574, with certificate of Title and Decree Number as mentioned above, owned by Liborio Pardo, Condrada Pardo de Vensilao, Heirs of Fermin Pardo and Manuela Pardo, located in the aforementioned barrio, for the additional school site of San Jose Elementary School, this City;

RESOLVED FURTHER, that the City Treasurer of Ormoc City, be authorized to pay the land owners or heirs concerned as above-mentioned, at the price or value as approved by the aforesaid Appraisal Committee; and

RESOLVED FINALLY, to request the Honorable City Fiscal Ormoc City to draw or execute a Document of the said Sale of Two(2) hectares of the Lots with Certificate of Title and Decree Number, mentioned above, for the school site purposes of the San Jose Elementary School, Ormoc City.
