RESOLVED FURTHER, That the necessary arrangements as embodied in the 2nd indorsement above-quoted can be done immediately.

RESOLVED FURTHERMORE, to respectfully request the said Directors PNB, Manila, that an Agency or Branch of the aforesaid Bank be established as early as possible.

RESOLVED FINALLY, that copies of this resolution be furnished His Excellency, the President of the Philippines, Malacañan, Manila, the Hon., the Secretary of Finance, Manila, Hon. Pio Pedrosa, Commissioner of the Budget, Hon. Carlos S. Tan, Senator-at-large, Hon. Domingo Veloso, Rep., 2nd District of Leyte and Hon. Jose Martinez, Rep. 1st District of Leyte, Congress of the Philippines, Manila, for their information and favorable action.
