RESOLUTION NO. 2

RESOLUTION OF THE MUNICIPAL BOARD OF ORMOC
CITY REQUESTING THE LEYTE LAND TRANSPORTA-
TION COMPANY TO CONTINUE ITS LINE IN
ORMOC CITY.

WHEREAS, there is a pressing need- because of
the volume of passenger and freight traffic - for
more and better motor transportation facilities in Or-
moc City proper and its fifty-eight (58) outlying but
progressive barrios.

WHEREAS, it is to the best interests and wel-
fare of the Ormocanos and the inhabitants of Ormoc
City that it be a free zone to all TPU operators, so
that the resulting competition would compel all operators
to render to the traveling public the maximum in efficiency
and courteous service;

WHEREAS, the Leyte Land Transportation Company
of Tacloban, Leyte, has proved to date the best TPU operator
in Ormoc City- maintaining a fleet of modern cars, prop-
erly equipped and managed- with regular round trips from
Ormoc City to Baybay, Palompon, Puertobello and Tacloban,
to the satisfaction of the motoring public;

WHEREAS, it has come to the knowledge of the
government of Ormoc City and its inhabitants that the
line of said company up to the Poblacion will be discon-
tinued in the near future on purely technical grounds
that are open to question, to the serious detriment of
the community; and

WHEREAS, the inhabitants of Ormoc City are
anxiously interested in the continuance and maintenance
of the present line of said company in said city because
of its standing record of top efficiency;

THEREFORE, on motion of Councilor Evangelista,
