RESOLUTION NO. 8

MUNICIPAL BOARD OF ORMOC PETITI 4 HIS EXCELLENCY, PRESI-MUNICIPAL A NEW LAW GRANTING A PERIOD OF DEFAULTED LOTS, OR PHOSE DECLARED PUBLIC, WITHIN WHICH TO FILE THEIR ANSWERS

WHEREAS, thousands upon thousands of lots, agricultual, residential, or otherwise, located in Ormoc City, are still pending hearing, notwithstanding the lapse of more than twenty years from the completion of the Ormoc Cadastral Survey;

WHEREAS, before the outbreak of the last global war, the Court of First Instance came to Ormoc only once in a blue moon for the purpose of trying cases - civil, criminal and cadastral - and then hardly stayed here for a week or two, to the regret and disappointment of the public, in general, and to the parties litigant, in particular;

WHEREAS, because of the brief stay here of the Court of First Instance during its pre-war sessions, it could hardly dispose of a handful of cases on the merits, leaving thus the cadastral cases untouched and untried;

WHEREAS, on account of the passing stays here of the said Court of First Instance, the owners of lots who were absent incapacitated or unknown could hardly be notified to enable them to go to town, hire counsel and prepare their answers in the usual, acceptable form;

WHEREAS, due to the long intervals between the court sessions in Ormot and the difficulty of getting in touch with the lot owners- whose whereabouts were, at times, hard to determine- thousands of lots, both in the city proper and (Over)
