An Act appropriating the sum of Fifty Six Million  
Twenty Thousand Pesos (P56,020,000.00) for Public Works  
(Republic Act No. 260) was approved by the First Congress  
of the Philippines in its current session, which sum of

It is again recommended that an appropriation of P600.00 for the purpose herein stated be authorized from the overcollections made from the internal revenue allotment, Ca-3, from any available fund not otherwise appropriated.
