FINALLY RESOLVED, that copies of this resolution be sent each to the Honorable City Mayor, this City; the District Engineer, the Division Superintendent of Schools, both at Tacloban, Leyte; and the City Treasurer, the City Engineer and the City Auditor, Ormoc City, for their information and guidance.
