2. Repair of Shop # 1, Central.....	557.14
3. Repair of Liloan Home Economics and Temporary building.....	200.00
4. Repair of San Antonio Elementary School...	300.00
5. Repair of Linac Elementary School.....	300.00
6. Repair of Libertad Primary.....	150.00
Total.....	P2,857.14
