RESOLUTION NO. 106

Councilor Rafael D. Omega announced to the Honorable members of the Board, the presence of Mr. Tomas Coching and Mr. Chu Lianté, two leading businessmen and prominent figure in the Chinese Community of Ormoc City.

Immediately, the Chair, in the name of the Honorable Body, expressed its desire to welcome the distinguished visitors and requested the members of this Municipal Board to hear their purpose.

Mr. Tomas Coching spoke and told the Honorable member of the Board that during the meeting of the Chinese Association in this City, of which he is the President, it was agreed that the Chinese Community would give a contribution of no less than P400.00 in cash for the celebration of the Ormoc City Festival on June 27, to July 4, 1949. He said further that the Chinese community would also contribute 20 cases of beer for the inauguration of the City Hall, Quonset Hut and Public Dispensary on July 1, 1949.

The Board, on motion of Councilor Flaviano Montesclaros, seconded by Councilor Cleto P. Evangelista,

RESOLVED, to pass a resolution to express the sincere and unanimous expression of gratitude of the members of the Municipal Board this City, to the local Chinese Community thru its President Mr. Tomas Coching and his companion, Mr. Chu Lianté, for the generous contribution of the Chinese elements on the occasion of the celebration of Ormoc City Festival, an act so expressive of cordial friendship and sympathetic cooperation;

RESOLVED FURTHER, to heartily accept, as it is hereby heartily accepted with sincere thanks on the part of the Municipal Board, this City, the generous offer as stated by Mr. Tomas Coching, President of the Chinese Association in open session of the Board;

RESOLVED FINALLY, that copy of this resolution of gratitude be furnished each to Mr. Tomas Coching, President of the local Chinese Community, Ormoc City; to Mr. Chu Lianté, Ormoc City; to Councilor Antonio C. Cataag, Ormoc City, Chairman of the Special Committee on Drinks.
