S i r s :

This is to inform that the undersigned has been appointed as City Health Officer of the City of Ormoc, effective May 10, 1949 at the rate of P3,000.00 per annum payable from the City.

It is further informed that the approved plantilla as the undersigned is actually receiving is P2,640.00 p.a. only, for the year 1948-1949. Since he could not claim at the rate of P250.00 monthly or P3,000.00 per annum, it is respectfully requested that an additional appropriation from May 10, 1949 to June 30, 1949 in the amount of P52.00 be provided together with a plantilla at the rate of P3,000.00 per annum instead of P2,640.00.
