RESOLUTION NO. 113

Resolution to officially take cognizance the promised allotments for barrio road constructions, Ormoc City as conveyed by His Honor, Lucilo A. Conui, City Mayor, Ormoc City to the Municipal Board, Ormoc City at its regular session, July 2, 1949; and expressing the gratitude of the people of Ormoc thru the Honorable, the Municipal Board, Ormoc City.

WHEREAS, there is a crying need of the barrio people of Ormoc City for the construction of barrio roads to give them better transportation facilities and bring to the consuming public for commercial purposes the products of their agricultural industries;

WHEREAS, be it known that of the 58 barrios within the boundary limits of Ormoc City, only around 15 barrios are along the National and Provincial Highways and these interior barrios are imminently and vastly agricultural and thickly populated by industrious, peaceful, and law abiding citizens;

WHEREAS, on the occasion of the celebration of our annual festival this year, His Excellency, President Elpidio Quirino of the Philippines, has emphasized in his message to the people of Ormoc to cooperate wholeheartedly in the government's present total economic mobilization program so as to build a strong, happy and prosperous country;

WHEREAS, the Municipal Board, Ormoc City and all the City Officials have publicly acclaimed the message of His Excellency and indorsed it to the people of Ormoc specifically to all barrio Lt. who in turn wholeheartedly promised to cooperate with the present administration;

WHEREAS, the City Mayor, His Honor, Lucilo A. Conui brought to the attention of the honorable members of the Municipal Board at its regular session, July 2, 1949, the desire of the Secretary of National defense, Honorable Ruperto Kangleon, Manila to give an allotment of P25,000.00 for barrio road constructions of the City of Ormoc;

WHEREAS, His Honor, Lucilo A. Conui, further manifested to the Honorable members of the Municipal Board the desire of the Secretary of Finance, Honorable Pio Pedrosa, Manila, who also promised an allotment of P25,000.00 for more barrio road constructions for the City of Ormoc;

S i r s :

We acknowledge to have received a copy of Resolution No. 62, with our humble expression of appreciation regarding the reconsideration of our salaries. But in the resolution we wish that special budget be provided even enough for 8 mos. only from Nov. 1948 to June 30, 1949 in the amount of P320.00 as additional appropriation, which could be taken from the salary savings of the Health Department of item of salaries. Part of the salary savings comes from the appropriation of City Health Officer which was vacant from Feb. to May 9, 1949, temporarily taken charge by the undersigned and saving of P40.00 monthly from June, 1948 to January 1949, because Dr. Fiel former Acting City Health Officer was given only P180.00 instead of P220.00 monthly in the plantilla, so that the saving in this particular position is about P803.00.

This office is cognizant that P300.00 was appropriated out of salary saving, but still it has a balance of about P503 of which we humbly request that P320.00 out of P503.00 be provided in connection with Resolution No. 62.

RESOLVED FINALLY, to authorize the City Treasurer, Ormoc City to prepare a supplemental budgeted for the purposes stated in the above quoted letter.
