RESOLUTION NO. 12

The Chair announced to the Honorable Body the necessity of creating a City School Board, Ormoc City whose duty shall be to supervise the activities of City Schools in order to solve City Schools problems.

The Board on motion of Councillor Victorino C. Teleron, seconded by Councillor Rafael D. Omega,

RESOLVED, that a City School Board be created which shall be composed of five (5) members whose duty shall be to supervise the activities of all City Schools public and Private now established and operating within the City of Ormoc with broad and general powers to help solve City Schools problems specially the enforcement of thrift, industry, and civic duties and good moral to the students.

RESOLVED FURTHER, to authorize the City Mayor Hon. Lucilo A. Conui to appoint the members of the City School Board whose chairman shall be a member of the Municipal Board, Ormoc City with four members to be selected from the rank and file of public spirited citizens who distinguished themselves in educational work;

RESOLVED FINALLY, that copy of this resolution be furnished each to the Director of Public Schools, Tacloban, Leyte; to the Division Superintendent of Schools, Tacloban, Leyte; to the District Supervisor, Ormoc II, Valencis, Ormoc Leyte; to the District Supervisor, Ormoc I, Ormoc City; to the Directress, St. Peters Academy Ormoc City to the Director of Western Leyte College; to the City Mayor, Ormoc City, City Treasurer, Ormoc City and the City Auditor, Ormoc City.
