RESOLUTION NO. 114

WHEREAS, the City Councilors are the official
representatives of the Legislative Branch of the City
Government created by Republic Act No. 179 otherwise
known as Ormoc Chartered City;

WHEREAS, the City Councilors of Ormoc City per-
form not only official functions expressly provided for
in the Charter itself but such other broad and implied
general powers as are necessary and consistent to carry
out the political, economic, social and educational as-
pirations of the sovereign people under which the City
Charter was created;

WHEREAS, The City Councilors of Ormoc City, loyal
and ever devoted to the service of the people of the City
of Ormoc wholeheartedly perform such duties at any time
of the day and night, rain or shine, and penetrate to the
interior barrios and sitios to attend to the official
functions and services above stated;

WHEREFORE, on motion of Councilor Margarito G.
Tugonon, seconded by Councilor Cleto P. Evangelista, here-
after, Be it Resolved, as it is hereby resolved to declare
official the attendance or presence of any Councilor or Coun-
cilors in any barrio or sitio within the City limits of
Ormoc City in furtherance of educational, economic or social
invitation extended by barrio people in Ormoc City, whether
such invitation be verbal or written;

BE IT RESOLVED FURTHER, that the Certification of
the City Mayor, Ormoc City on vouchers calling for reim-
bursement of expenses officially incurred by any City
Councilors or members of Municipal Board of Ormoc City in
connection with the economic, social or education functions
or duties as above mentioned under the general and implied
powers of the City Charter as above stated, be a requisite
to make such presence or attendance official in nature;

BE IT RESOLVED FURTHERMORE, to declare official, as
it is hereby declared official, the special trip to barrio
Lao, Ormoc City of Councilors Rafael D. Omega, Tugonon, and
Pajaron in the amount of P10.00, requesting the City Auditor,
Ormoc City to immediately approve for payment the voucher co-
vering the above mentioned amount; and requesting lastly to

hurry up the approval of the payments for repair of the tables and chairs and other requisitions of the Municipal Board, Ormoc City in view of the fact that the members of the Board have been holding sessions without tables and chairs while deliberating on official business of vital concern to the City Government.
CARRIED UNANIMOUSLY.
